### M.A.185/2016 in O.A.1082/2014

Heard Smt. N.G. Gohad, the learned Presenting Officer for the Applicants (Ori. Respondents).

This is an application for extension of time to comply with our order dated 22<sup>nd</sup> January, 2016 by three months from today. Notice has not been directed to be issued. However, in view of the course of action that we are going to adopt even the original Applicant is not going to be seriously prejudiced.

It would appear quite clearly from the order of 22<sup>nd</sup> January, 2016 made by us in this Bench that we noted that the original Applicant had already been promoted pending OA and directions were given to take a decision about the deemed date within two months from that date.

Now, in fact, this application came to be presented on 16<sup>th</sup> April, 2016 which was after the time limit had expired. Therefore there is no question of granting three months time and taking into consideration all aspects of the matter, final extension is granted for a period of one month from today and it is made clear that no further extension shall be granted. We have also recorded the fact that the Government has accepted the order of this Tribunal dated 22<sup>nd</sup> January, 2016 and they do not want to challenge it before the Hon'ble High Court. The MA is disposed of with no order as to costs.
