
2. This is an application for transfer of O.A. from Nagpur Bench to Principal Seat at Mumbai. O.A. is of the year 2016.

4. Hence, in view of the foregoing following order is passed :-


- (a) O.A. No. 666/2016 is transferred to Principal Seat at Mumbai for hearing and disposal according to law.
