## JUDGMENT

- 1. In this M.A. the State of Maharashtra seeks extension of time to implementation the order of the Tribunal dated 14.10.2021 by which the Respondent-Department is directed to conduct the meeting of Departmental Promotion Committee (D.P.C.) on the basis of existing Rules or new Recruitment Rules whichever are in force and complete the process as on 01.01.2022.
- 2. We have passed order on 18.01.2022 in this M.A. wherein we have mentioned that as the M.A.T. Bench Nagpur has granted stay in identical matter by order dated 17.12.2021 in O.A.No.538/2021 therefore the D.P.C. could not be presided and the order dated 14.10.2021 passed in O.A.No.636/2021 could not be complied with. We have specifically mentioned in the said order that,
  - "4. It appears that the M.A.T., Nagpur Bench is not aware of the order dated 14.10.2021 passed by the Principal bench, Mumbai in this Original Application. It was necessary for the learned P.O. Nagpur Bench to place the order dated 14.10.2021 of the M.A.T Principal Bench, Mumbai before the Nagpur Bench.
  - 5. *In view of this, the matter is adjourned to 7.2.2022.:*

- 3. The learned C.P.O. for the Respondents submits that the Department has constituted the D.P.C. and wants to proceed to comply with the order dated 14.10.2021. However, she submits that 13 Government employees holding similar posts have approached this Tribunal challenging the said seniority list who are placed below 190 numbers in respect of their placements stating that they are to be placed at serial No.24, 25 and 27. At M.A.T. Bench Nagpur in O.A.No.538/2021 by order dated 31.01.2022 at paragraph 5 it is held that,
  - 5. ..... However, as submitted by the applicants, their seniority list as on 1/1/2020 published on 4/5/2021 (A-5, P-154) is erroneous. The respondents are directed to first correct the seniority list of the applicants as on 1/1/2020 published on 4/5/2021 (A-5, P-154) as per para-3 of the order of this Tribunal dated 12/7/2021. The respondents are further directed to solve the applicants' grievance, then proceed with the DPC as per the order of MAT, Principal Bench dated 18/1/2022 in M.A.607/2021 in O.A.636/2021.
- 4. Considering the view taken by our Brother Judges of M.A.T. Bench Nagpur we made following queries to the learned P.O. with a view to resolve the issue:-
  - (a) All the 13 Applicants, if succeed and their seniority as per their claim is allowed, then who is going to be topper in those 13 Applicants and will be placed at which serial number in the seniority list "
  - Ans. The learned P.O. on instructions from Mr. Rajendra S. Sankhe, Assistant Apprenticeship Advisor (T), has produced the chart which is reproduced here in below:

The learned P.O. has submitted that out of 13 Applicants, first one will be placed at serial No.146, if they succeed in their claim of seniority.

(b) How much time is required to update the entire seniority of 327 people including seniority of 13 Applicants.

Ans. The learned P.O. requested for five weeks time.

- 5. Thus, in view of the information furnished to us by the Department and factually the applicants in the present O.A. before us are admittedly above 140 number, as they stand at serial no.24, 25 and 27 (corrected serial number). The promotions of the candidates from 1 to 120 are not to be stalled and can be promoted when nearly 100 posts are vacant, so that administration will not be stalled. D.P.C. to be conducted within two weeks.
- 6. The learned P.O. Nagpur Bench is directed to place this order before the M.A.T. Bench Nagpur.
- 7. With above directions, M.A. is disposed of.
