- 5. Thereafter, the Respondent no. 2 has come forward. Respondent no. 2 is identified by Shri Pramod Jadhav, Law Officer,

from the office of Commissioner of Police, Navi Mumbai, Respondent no. 1. Respondent no. 2 was called to state as to whether he has received notice of this Tribunal.

- 6. Respondent no. 2 undertakes that he shall engage lawyer or he shall filed his affidavit within one week.
- 7. Learned P.O prays for time for filing reply on the ground that charge of the post of A.C.P (Admn) is held by Respondent no. 2 himself, and he could not have filed affidavit for the Govt.
- 8. Be it as it may, however, affidavit ought to have been filed because over a month's time is already granted to the Commissioner of Police, Navi Mumbai.
- 9. Therefore, Shri Hemant Nagrale, Commissioner of Police, Navi Mumbai, is called to show cause as to why he should not be personally saddled with cost for failure to file reply, when notice of this Tribunal was served on Res. No. 1 on 17.2.2018 itself and more than one month has passed.
- 10. Considering request of learned P.O one weeks' time is granted for filing reply. Affidavit of the Commissioner of Police, Navi Mumbai, be filed.
- 11. Let the O.A come up for final disposal on 3.4.2018.
- 12. Steno copy and Hamdst is allowed. Learned P.O is directed to communicate this order to the Respondents.
