1. Heard Smt Punam Mahajan, learned advocate for the Applicants and Ms S.P Manchekar, learned Chief Presenting Officer for the Respondents.

2. Applicants have prayed as under:-

“9(b) That this Hon’ble Tribunal be pleased to direct the Respondents to consider the Applicants for promotion to the post of Assistant Commander/Adjutant on the basis of the G.R dated 28.4.1967 and orders in contravention to the G.R dated 28.4.1967 and on the basis of the combined gradation list of Police Inspector (S.R.P.F) and Reserve Police Inspector.”

3. Learned advocate for the applicants have attached list of Officers in the rank of Inspectors at page 28, Annexure A-1. It is stated that the Inspectors after completion of 3 years are in the zone of consideration and after examining their suitability, they are considered for promotion to the next grade.

4. At present it is submitted that a Combined Seniority List of Armed Police Inspectors from SRPF and Reserved Police Inspectors from the

District is prepared for promotion to the post of Deputy S.P/Assistant Commandant.

5. Annexure A-2, is the copy of the rules for promotion for the post of Assistant Commandant, (Page 32). Relevant portion of the same reads as under:-

“Appointment shall be made either:-

- (a) by promotion of suitable (Battalion Commander (Inspector), or.....”
(Quoted from page 32 of the O.A)

6. In view of the foregoing, Respondents are directed to ensure that all the Officers as mentioned in Annexure A-1, who have completed 3 years and are suitable for promotion, should be considered for promotion when the D.P.C meets next time, depending upon the vacancies.

7. With the above directions, Original Application stands disposed off. No order as to costs.
