- 1. Heard Shri R.M Kolge, learned advocate for the Applicants and Shri A.J Chougule, learned Presenting Officer for the Respondents.
- 2. Both the Original Applications are heard and disposed of together as the issues involved are the same.
- 3. The Original Application was filed on 9.4.2018. Today during final hearing, learned advocate for the applicant submits that G.R has been issued on 10.12.2018. Para 3 of the G.R reads as under:-

"राज्य, राखीव पोलीस बलातून जिल्हा पोलीस दल / इतर घटकात विनंतीकरून बदलून जाण्या-या कर्मचा-यांची सेवा जेष्ठता निश्चित करताना, संबंधित राज्य राखीव पोलीस बलाव्या कर्मचा-यांचे भरती वर्षे प्रमाण मानले जाईल व राज्य राखीव पोलीस बलातील बदलून जाणारी कर्मचारी ज्या वर्षी राज्य राखीव पोलीस बलात भरती झाला असेल त्या वर्षातील जिल्हा पोलीस दलात भरती झालेल्या सर्व कर्मचा-यांच्या सर्वात शेवटी त्याला सेवाज्येठता दिली जाईल व त्या वर्षात त्याच्या प्रवर्गातील कर्मचारी ज्या पदावर कार्यरत आहेत त्या पदावरच तो नियुक्तीस पात्र राहील."

Senior Clerk, in the office of Superintendent of Police, Raigad, submits

that the seniority list is at present being compiled afresh as per

directions issued in the G.R dated 10.12.2018.

6. The Respondents submit that the fresh seniority list would be

prepared within a period of one week. Even then, I am inclined to give

them four weeks, so that no errors are left in the same. Thereafter, the

decision should be taken expeditiously within a period of two weeks

regarding consequential benefits to the applicants and same is

communicated to the Applicants within a week.

7. With above directions, both the Original Applications are disposed

off with liberty. No order as to costs.
