## ORDER

- 1. Heard Shri Arvind V. Bandiwadekar, learned advocate for the Applicant and Ms Archana B.K, learned Presenting Officer for the Respondents.
- 2. Learned advocate for the applicant submits that his case is identical to the one which was decided earlier in O.A 264/2018, decided on 24.10.2018.
- 3. The order reads as under:-
  - "5. The State has further averred that applicant's actual promotion is kept pending on account of pendency of matter before Hon'ble High Court and Hon'ble Supreme Court.
  - 6. Admittedly, the matters pending before the Hon'ble High Court and Hon'ble Supreme Court relates to accelerated promotion of the candidates other than those promoted on seniority-cumfitness category.
  - 7. We, therefore, see no reason entitling the Government to withhold the decision to promote the applicant.
  - 8. In view of the foregoing, following order is passed:-
  - (a) Original Application is allowed in terms of prayer clause 9(a), which reads as follows:-
    - "9(a) By a suitable order/direction, this Hon'ble Tribunal may be pleased to set aside the order dated 20.9.2017 passed by the Respondent no. 1 (Exhibit-A) to the extent to which the same has not included the name of the Petitioner being promoted as Police Sub-Inspector and accordingly the Respondents be directed to forthwith promote the Petitioner to the post of Police Sub-Inspector and to grant him the deemed date with effect from 20.9.2017 together with all the

consequential service benefits, as if the impugned order has not been passed."

- (b) Compliance be done within 15 days from today.
- (c) In the circumstances, parties are directed to bear their own costs."
- 4. During the hearing, learned P.O mentions as under:-
  - "श्री. वाव्हळ यांचा भरती दिनांक ०५/०३/१९८८ व प्रवर्ग वि.मा.प्र. असा आहे. श्री. वाव्हळ यांच्या जात प्रवर्गातील व त्यांचे सोबत म्हणजेच दि.०१/११/१९८८ पर्यंत भरती झालेल्या अंमलदारांना पोलीस उप निरीक्षक पदाची पदोन्नती देण्यात आली आहे. त्यामुळे श्री.वाव्हळ हे देखील त्यांचे भरती दिनांक व जात प्रवर्गानुसार पोउनि पदाच्या पदोन्नतीस पात्र ठरतात.
  - २. तथापि, श्री. वाव्हळ हे विशेष मागासवर्गीय कर्मचारी असल्याने तसेच त्यांनी दि.२५/०५/२००४ नंतर पोहवा ते सहायक पोलीस उपनिरीक्षक पदच्या पदोन्नतीमध्ये आरक्षणाचा लाभ घेतल्याचे दिसून येते त्यामुळे शासन पत्र क्र. बीसीसी-२०१७/प्र.क्र.३१२A/१६-ब, दि.२९/१२/२०१७ मध्ये मार्गदर्शक सूचनानुसार श्री. वाव्हळ यांना सद्यःस्थितीत पोलीस उप निरीक्षक पदावर पदोन्नती देता येणार नाही. "

The order issued by this Tribunal on 24.10.2018 had already considered the submission and passed the order.

- 5. As there is no difference between the case which has been already decided and the present case, we pass the following order.
  - (a) Original Application is allowed in terms of prayer clause 9(a) which reads as follows:
    - a] By a suitable order/direction, this Hon'ble Tribunal may be pleased to hold and declare that as per 5 of the impugned order dated 24.3.2017 (Exhibit-A) issued by the Respondent no. 1, that the Petitioner was / is entitled for the deemed date, namely, 1.7.2014 along with promotion in the post of Police Sub Inspector in view of the Petitioner being fully eligible, qualified and suitable.
  - (b) Compliance be done within 15 days from today.
  - (c) In the circumstances, parties are directed to bear their own costs.

6. Steno copy and Hamdast is allowed. Learned P.O is directed to communicate this order to the Respondents.
