and not in the pay band of Rs. 15600-39100 with Grade Pay of Rs. 5700/- attached to the said post and accordingly the petitioner be granted all the consequential service benefits, as if the impugned order was not passed."

During hearing, learned advocate for the applicant on instructions from the applicant, who is present, submitted that he was in correspondence with the Respondents prior to the issuance of the order dated 28.5.2019. He submits that he proposed to make further representation in this regard following the order on 28.5.2019. He seeks that the Respondents may be directed to decide his representation

expeditiously.

4. Learned P.O submits that once the representation is made, the concerned Respondents would be instructed to ensure that the
