Heard Shri R.V. Shiralkar, learned counsel for the applicant and Shri S.A. Sainis, learned P.O. for the respondents.

2. The applicant is appointed on the post of Jail Guard. He was posted at Buldhana. The applicant is resident of village Vihe, Tah. Patan, District Satara. The father of applicant is suffering from Cancer. The applicant was transferred from Buldhana to Kolhapur. The applicant is seeking request transfer as per the G.R. dated 03/06/2011.

3. It is submitted that the applicant has completed 5 years of

service and post is vacant at Satara and therefore he is praying for

inter-district transfer.

4. The O.A. is strongly opposed by the respondents. It is

submitted that the post equivalent to the post of applicant is not

available at Satara, therefore, the applicant cannot be transferred.

5. During the course of submission the learned counsel for

applicant has filed the advertisement issued by the respondents. As

per this advertisement, the post of Jail Guard is vacant at Satara and

therefore the applicant can be transferred to Satara. Hence, the

following order -

<u>ORDER</u>

(i) The O.A. is allowed.

(ii) The respondents are directed to consider the claim of the applicant

for inter-district transfer as per the G.R. dated 03/06/2011, if he is

eligible for the same.

(iii) The concerned Officer may issue "No Objection Certificate" for

transfer of the applicant to transfer him at Satara.

(iv) No order as to costs.
