Heard Shri K.R. Jagdale, the learned Advocate for the Applicants and Shri A.J. Chougule, the learned Presenting Officer for the Respondents.

By consent, the OA is taken up for final disposal. The 14 Applicants herein have brought this OA seeking regularization in their service after condoning the breaks such as they were. Now, it is clear that the subject matter covered by prayer clause (b) is that in the alternative, the Respondents be given a direction to decide the representations of the Applicants submitted on 9.3.2015 and 10.3.2015 and to communicate the decision thereon to them forthwith. In my opinion, in order to avoid any technical objection as regards substantive aspect of the matter, this OA can be disposed of in terms of prayer clause 10(b). This OA therefore disposed of with a direction to the Respondents to consider and decide the two representations above referred to within a period of six weeks from today and communicate the decision to the Applicants within one week thereafter. No order as to costs.
