JUDGMENT

(Delivered on this 2nd day of January,2020)

Heard Shri K. Nalamwar, learned counsel for the applicant and Shri M.I. Khan, learned P.O. for the respondents.

2. In this case the applicants were initially appointed are the Technical posts within the purview and jurisdiction of Subordinate Selection Board. All the applicants were appointed through Employment Exchange and Social Welfare Department after completion of necessary procedure of appointment and were granted

initial appointment accordingly. The Regional Subordinate Selection Board published an advertisement in March-April, 1990 for filling up the posts of Class-III / Group- C in the Government Printing Press and Book Depot, Nagpur. The filling up of these posts were within the purview of Subordinate Selection Board, Nagpur. Upon completion of the procedure recommendation by the Selection Committee and in pursuance of Government Resolution of General Administration Department dated 2/5/1988 these applicants were appointed initially for three months during the same period on different technical posts. The first appointment order for three months on 26/3/1990 as collectively filled on record as Annex-A1 to this original application. Subsequently, in the months of June, 1990 this three months period was then extended for further period of three months. All these orders are collectively placed on record as Annex-A-2 to the O.A.

3. The Sub Ordinate Selection Board initially proceeded for regularization of services of these applicants. This process was challenged by the Government Press Employees Union, Nagpur by filing Writ Petition in the Hon'ble High Court, therefore, the process of regularization could not be completed. The said Writ Petition was then transferred to this Tribunal upon its formation and this Tribunal directed the Subordinate Selection Board to complete the process of regularization.

4. By G.R. dated 10/11/1998 & 1098/63908-1908 m?kx 4 dated 18th August, 2000 (A-3,P-71) and G.R. dated 19th April, 2005 (A-4,P-74) the applicants were regularized by the Government of Maharashtra and vide G.R. 31st December, 2003 (A-5,P-77) directed that the seniority of all these applicants will be considered from 8/3/1999.

5. In the reply filed by the respondents in para-13, page no.165 it has been mentioned that the matter is consideration of the respondent no.1 and appropriate action will be taken on the same being considered by the respondent no.1.

6. In view of this, the following order –

ORDER

- i) The O.A. is partly allowed.
- ii) The relief clause nos. 7 (A) and (B) are allowed.
- iii) The respondent no.1 is directed to take decision as mentioned in para-13, page no.165 in the reply filed by the respondents dated 15th October, 2018 In the O.A. within three months from the date of this order.
- iv) No order as to costs.
