JUDGMENT

(Delivered on this 27th day of April 2018.)

Heard Shri P.V. Thakre, the learned counsel for the applicants and Shri M.I. Khan, the learned P.O. for the respondents.

- 2. All these applications are being disposed of by this common order, since the issue involved in all these matters is one and the same.
- The applicant in O.A. No. 256/2009 Kalidas Laxman Kalbandhe is working as a Driver and was appointed initially on 8.3.1990 at the regional office (DVAT), Nagpur. His services have been regularized on 8.3.1999 in view of orders issued by respondent No.1 i.e. the Secretary, Department of Higher and Technical Education, Mumbai dated 25.5.1999 and 13.12.1999.

- 4. The applicants in O.A.No.360/2009 are working as Instructors in the respective I.T.Is and were initially appointed on *ad hoc* basis. They were subsequently selected by the Divisional / Regional Selection Board and their services have been regularized in view of G.R. dated 8.3.1999.
- 5. The applicants in O.A.No.359/2009 are working as Instructors in the respective I.T.Is and though, they were initially appointed on temporary basis, their services have been regularized on 8.3.1999 in view of the G.Rs issued by the respondent No.1 on 25.5.1999 and 13.12.1999.
- 6. The applicants in O.A.No.822/2009 are working as Clerk-cum-Typists in the respective I.T.Is and their services are also regularized on 8.3.1999 in view the orders issued by respondent No.1 i.e. the Secretary, Department of Higher and Technical Education, Mumbai on 25.5.1999 and 13.12.1999.
- 7. According to the applicants, as per the G.R. dated 1.11.1983, a decision was taken for abolition of the Selection Board and that services of temporary / ad hoc employees should be regularized from the date of their initial appointment on ad hoc basis. Number of decision were taken by the Government and various G.Rs were issued to regularize the services of temporary

employees. On 24.1.1990, it was decided that the Govt. employees who were selected in the year 1988 by the Selection Board, their selection have been included from the purview of Regional Selection Board and, therefore, it was decided that their appointments shall be considered as regular appointment and it was also directed to give them seniority from the date of their initial appointment.

8. Vide G.R. dated 5.2.1990, the employees who were appointed prior to 8.6.1983 were not selected by the Regional Selection Board, it was decided to regularize their services in view of a decision taken by the Hon'ble High Court in W.P. No.3685/1984 and accordingly services of the employees were regularized from the date of their initial appointment. Almost similar decisions were taken vide G.R. dated 19.9.2001 by the Department of Social Justice and Special Assistance, G.R. dated 20.11.2003 by the Department of Rural Development and a G.R. dated 16.1.2004 by the Department of Tribal Development. On the basis of the G.R. dated 8.3.1999, services of ad hoc employees in various departments under the Govt. of Maharashtra were regularized and their seniority was considered from the date of their initial appointment. Thus, various departments the Govt. of 28

Maharashtra have taken conscious decision to regularize the services of their respective employees from the date of their initial appointment.

On 31.7.2007, the Union of the applicants demanded 9. that the services of the applicants shall be regularized in view of G.R. dated 8.3.1999 and they shall be given seniority from the date of their initial appointment alongwith other demands. The meeting was held with the representatives of the respondent No.2 i.e. the Dy. Secretary and other officials and non-officials and it was decided that the Director of Vocational Education and Training should prepare a proposal in respect of demands of the Union of the applicants and to place it in the meeting before the Govt. Accordingly, meeting was held on 23.8.2007 which was attended by the respondent Nos. 2 and 3. In the said meeting, a proposal for granting seniority from the date of initial appointment to the applicants will be submitted to the Govt. on or before 30.9.2007. Since no decision was taken by the Govt., the applicants have filed All the applicants are claiming directions to the these O.As. respondents to consider their cases for granting them seniority on their respective posts from the date of their initial appointment and to pay them consequential benefits thereon.

- 10. The respondent No.3 i.e the Joint Director, Vocational Education and Training, Nagpur has filed affidavit in reply in all the matters and submitted that the services of the applicants have been regularized in the year 1999 and they are challenging their regularization after ten years and, therefore, the application is barred by limitation. It is stated that the respective appointed purely on ad hoc basis. applicants were Government has taken a decision to regularize the services of such temporary and ad hoc employees on certain conditions as a one time special case and in view thereof, the Govt. of Maharashtra has issued a G.R. dated 8.3.1999 in respect of 3761 ad hoc working in different departments of the Govt. of employees Maharashtra. In the said G.R., six conditions were mentioned for The applicants have accepted those conditions regularization. and accepted the order of regularization and conditions therein and, therefore, they cannot claim that they were not properly regularized.
- 11. Admittedly, the services of all the applicants have been regularized vide G.Rs dated 8.3.1999 and 19.3.1999. Copies of the said G.Rs are placed on record in all the applications and, therefore, such copies in O.A. No. 256/2009 are considered.

The G.Rs are at page Nos. 23 and 24 (both inclusive) and at page Nos. 25 and 26 (both inclusive) at Annexure-C and Annexure-D respectively. From these G.Rs., it is clear that the Govt. has decided to regularize the services of various employees. As per Annexure-C dated 8.3.1999, it was decided to regularize the services of 3761 employees whereas as per the G.R. dated 19.3.1999 (Annexure-D), services of 1061 employees were regularized. The relevant decision for regularizing the series of the applicants taken vide both the G.Rs is the same and the relevant decision is as under:-

- (अ) संबंधित कर्मचाऱ्यांने सेवाप्रवेश नियमाप्रमाणे विहित केलेली शैक्षणिक अर्हता व वयाची अट मूळ नियुक्तीच्या वेळी पूर्ण केलेली असावी.
- (ब) दि. ३१ डिसेंबर १९९७ रोजी एक वर्षाची सलग सेवा

झालेली असावी व कामांचा दर्जा किमान चांगला असावा.

- (क) पदे उपलब्ध नसावीत.
- (ड) नियमितीकरण करताना आरक्षण बिंदू आणि समांतर आरक्षण, यासंदर्भात तत्वांचे / नियमांचे पालन करण्यात आले असावे.
- (इ) कर्मचाऱ्यांची सेवाज्येषठता प्रस्तुत आदेश निर्गमित झाल्याच्या दिनांकापासून धरण्यात यावी.
- (ई) अभावित नियुक्तीचा फायदा कुठल्याही प्रयोजनार्थ/कारणांसाठी देण्यात येणार नाही.

संचालक, व्यवसाय शिक्षण व प्रशिक्षण यांनी याबाबतचे स्वतंत्र आदेश निर्गमित करून अभावित नियुक्त्या नियमित कराव्यात. तसेच भविष्यात अशाप्रकारे अनियमित नियुक्त्या होणार नाहीत, याबाबत योग्य ती दक्षता घ्यावी व तशा सूचना त्यांच्या अधिपत्याखालील नियुक्त्या प्राधीकार्ऱ्यांना द्याव्यात. भविष्यात ज्या प्रकरणी वरील कार्यपद्धतीचे पालन करण्यात येणार नाही, त्याप्रकरणी संबंधित अधिकारी / कर्मचारी यांच्यावर जबाबदारी निश्चित करण्यात येजन, त्यांच्याविरुद्ध आवश्यक ती कारवाई करण्यात यावी."

The terms and conditions of the aforesaid decision clearly show that the seniority of the employees to be regularized was to be considered from the date of issuing of the respective G.Rs i.e. the G.R. dated 8.3.1999 and 19.3.1999 respectively. Accordingly, the regularization orders of the

applicants were issued. One of such order for reference has been considered in respect of the applicant in O.A.No.256/2009 which is at page Nos. 29 to 32 (Annexure-5). Perusal of the said order clearly shows that the regularization was given effect from the date on which services of the employees are regularized and in this regularization order also, it clearly stated that seniority of the employees, whose services have been regularized shall be from the date of issuance of the G.R. Condition No.3 is material which reads as under:-

"कर्मचाऱ्यांची सेवाज्येष्ठता प्रस्तृत शासन आदेश निर्गमित झाल्याच्या दिनांकापासून अंतर्गत वर्षानिहाय ज्येष्ठतेनुसार धरण्यात येईल."

13. The learned counsel for the applicants submits that in the minutes of the meeting between the Union and the respondent authorities, it was decided that the respondents will submit a proposal to regularize the services of the employees from the date of their original appointment on or before 30.9.2007. The minutes of the said meeting have been placed on record at page Nos. 18 to 21 (both inclusive). It is material to note that, this meeting has taken place on 23.8.2007 and a proposal was to be forwarded on 30.9.2007. It is not known as to whether a proposal

was forwarded or not. However, the respondents have accepted the order of regularization of employees and their appointment order is also in view of the G.Rs dated 8.3.1999 and 19.3.1999 and both these G.Rs clearly states that the employees were to be regularized and their seniority was to be considered from the date of issuance of the G.R. Therefore, the applicants at the most can claim regularization from the date of G.Rs dated 8.3.1999 and 19.3.1999. The alleged minutes of the meeting between the respondents and the Union of the employees cannot give rise to any legal right of the applicants. In view thereof, we do not find any merits in these O.As. Hence, we proceed to pass the following order:-

ORDER

All the O.As are dismissed with no order as to costs.
