

**J U D G M E N T**

1. Heard Shri D.B. Khaire, learned Advocate for the Applicant and Shri N.K. Rajpurohit, learned Chief Presenting Officer for the Respondents.

2. This O.A. has been filed by the Applicant who is working as Grade "B" Medical Officer in Yerawada Central Jail, Pune and who would be completing three years in that post in the month of July, 2016.

3. Learned Advocate for the Applicant Shri D.B. Khaire stated that the Applicant's daughter is now come to 12<sup>th</sup> standard in a prestigious college in Pune and his only anxiety is he may be allowed to remain in Pune for one more year so that applicant's daughter may complete her 12<sup>th</sup> standard in Pune.

4. Learned C.P.O. for the Respondents Shri N.K. Rajpurohit states that the proposal to transfer the applicant has already been submitted. Learned C.P.O. for the Respondents on instructions from Shri R.D. Kulkarni, Administrative Office, Director Public Health, Mumbai, states that there are some complaints about the conduct of the Applicant.

5. Learned C.P.O. for the Respondents was kind enough to place before me for perusal of the report sent by the Director of Health Service to State Government for transfer of the applicant. The applicant himself is seeking transfer from Yerawada Central Jail, Pune and his only request is for a posting in Pune in any post.

6. Respondents may consider his request in the light of the fact mentioned by him that his daughter is studying in 12<sup>th</sup> Standard. His representation dated 28.04.2016 may be considered by the Respondents while making transfer order during ensuing general transfers. This O.A. is disposed off accordingly with no order as to costs.
