- 2. Applicant, a Clerk/Typist in the office of Zilla Sainik Board posted in District Sainik Board, Nagpur has been transferred to Zilla Sainik Board, Bhandara by order dated 24.12.2018.
- 3. Applicant claims that he has been relieved by Nagpur office, however, the Respondent No.2 has not allowed him to join and has addressed a letter to Director of Sainik Kalyan Department, Pune dated 14.1.2019.
- 4. Text of letter dated 14.1.2019 Annexure A-8 page 34 is quoted below:-

(a) Contents of letter dated 14.1.2019, Page 34 are factually incorrect, false or contrary to record or

otherwise wrong.

(b) Letter dated 14.1.2019 is contrary to mandatory

provision of law.

(c) Grounds on which writ of mandamus can be issued.

6. In view of foregoing deficiencies in the O.A. which go to

the root of case, O.A. has no merit.

7. Hence O.A. is dismissed with costs.
