## **JUDGMENT**

2. The applicant was transferred from Gondia to Jalgaon. As per the submission of learned counsel for applicant, two posts are vacant at Wardha and Zilla Parishad, Bhandara. As per the direction of this Tribunal, the representation was made by the applicant.

3. The ld. P.O. has pointed out para nos. 9 and 10 of the

reply. As per this reply, the representation /preferences of the

applicant dated 24/02/2023 is submitted to the competent authority i.e.

the Minister of Water Supply Sanitation for reconsideration.

4. In para-10, it is submitted that as per the decision of

Maharashtra Administrative Tribunal dated 19/06/2023, the applicant

has given application dated 20/06/2023 and the same has been

submitted to the Minister of Water Supply Sanitation.

5. There is no dispute that the applicant is already relieved.

Hence, stay to the impugned order cannot be granted. Stay was not

granted on merit also. The applicant is already relieved. Moreover, as

per the reply, the service of the applicant is necessary at Jalgaon for

the scheme floated by the Central Government. Five posts are vacant

at Jalgaon. Hence, the impugned transfer order cannot be said to be

illegal. Hence, the following order -

**ORDER** 

(i) The O.A. is dismissed with no order as to costs.

(ii) However, the respondents may decide the representation of the

applicant sympathetically.
