- 4. Applicant's mother Neeta was serving as Sister Nurse and expired on 5.4.2004 due to heart attack. The applicant being a son, sought appointment on compassionate ground. But his application is rejected vide communication dated 22.1.2015 (A.1, P.18) passed by Deputy Director of Health Services, Nagpur and further communication dated 31.1.2015 (A.2, P.20) issued by Medical Superintendent on the ground that the application was filed late by five months. Applicant's case is put in tabular form giving clear picture.
