## <u>JUDGMENT</u>

Heard Shri A.Mardikar, Id. counsel for the applicant and Smt. S.V.Kolhe, Id. P.O. for Respondents.

The applicant Prashant Krushnaraoji Ingole has filed thisO.A. for direction to R-2 to appoint him on a suitable post as per his

qualification on compassionate ground condoning the period of limitation.

- 3. The applicant belongs to OBC category and his father Krushnaraoji Ingole was working as Head Constable and died on 04/04/1983 due to prolong illness during his service period. The applicant was minor at that time. He has become major in the year 2000.
- 4. The applicant has filed application for appointment on compassionate ground but his application was not considered and hence this O.A..
- 5. The R-2 submitted that the applicant's father died on 04/04/1983 and the applicant didn't filed application for compassionate appointment within five years from the death of his father and even within one year from the date of attaining majority and therefore he cannot be considered for compassionate appointment.
- 6. Perusal of the records shows that for the first time the applicant filed the application for appointment on compassionate ground on 15/10/2015 as per **Annexure-A-5** vide letter dated 07/11/2015 (**Annexure-A-6**). The applicant was intimated that his application cannot be considered since it was not filed within five years from the death of his father and even within one year from the date of attaining majority. Similar communication was issued to the

applicant again in 2016 vide letter number 3340/2016, copy of which is

at paper book page number 16. Applicant was also asked as to

whether he has filed any application for compassionate appointment

within limitation. The applicant didn't reply that guery and has filed this

O.A.

7. From the facts on the records it will be crystal clear that

though the applicant's father died on 04/04/1983, the application for

the compassionate appointment has been filed after a long period that

is on 15/10/2015. The applicant's claim has, therefore, been rightly

rejected by the respondents authority while communication dated

07/11/2015. I therefore don't find any illegality in the communication

dated 07/11/2015. Appointment is not a vested or hereditary right in

the L.R.'s of disease employees. Hence the following order :-

**ORDER:-**

Application stands dismissed with no order as to costs.
