JUDGMENT

Heard Shri R.M. Fating, learned counsel for the applicant and Shri A.P. Potnis, learned P.O. for the respondents.

- 2. The applicant has filed this O.A. to declare him that he has attained permanency in service w.e.f. 18/04/2008 and direct the respondents to release the regular pension etc.
- 3. During the pendency of the O.A., the departmental inquiry is concluded. The applicant is getting provisional pension.
- 4. Heard the learned counsel for applicant Shri R.M. Fating. He has filed Pursis along with documents. It is taken on record and marked Exh-X for identification. As per his submission, departmental inquiry is completed and proposal is forwarded by respondent no.4 to respondent no.1 requesting to give the continuity of service to the applicant. The query was made by respondent no.1 to respondent no.4 directing as to whether the applicant had obtained the permission to appear in the MPSC examination. The query was replied by the applicant. He has stated in his reply dated 6/5/2022 stating that he had applied for permission on 14/02/2005. As per the submission of learned counsel for applicant, if permission is not granted within 30 days, it is deemed to be granted.
- 5. Heard learned P.O. Shri A.P. Potnis. He has pointed out the Government order dated 17/06/2021.
- 6. There is no dispute that the departmental inquiry is already completed. The applicant is getting provisional pension. Now only

issue is about as to whether the applicant is entitled for continuity of

service. The applicant has replied by letter dated 06/05/2022

addressed to the Additional Commissioner, Tribal Development

Department, Nashik-2.

7. Hence, the respondents are directed to decide the

continuity of service of applicant as per proposal made by respondent

no.4 to respondent no.1 dated 04/10/2021 within a period of three

months from the date of receipt of this order.

8. With this direction, the O.A. is disposed off. No order as to

costs.
