### Tribunal's orders

#### O.A.No.965 of 2015

1. Heard Shri B.A. Bandiwadekar, learned Counsel for the Applicants and Smt. K.S. Gaikwad, learned Presenting Officer for the Respondents.

2. This O.A. has been filed by the applicants seeking relief that they should be granted benefits like yearly increments, pay fixation, arrears of difference of pay and allowance etc. which was given to the persons working in other Districts on the basis of the same selection process.

3. Learned P.O. placed on record a copy of letter dated 31.12.2015 issued by the Director of Health Services, Mumbai to the Deputy Director Health Services, Mumbai in respect of present applicants and the same is taken on record and marked as document 'X'.

4. On instructions of Dr. Kempi Patil D.C. Civil Surgeon, Thane who is present before the Tribunal, learned P.O. states that benefits like annual increments, arrears of pay, if any, would be paid to the Applicants for the period they were actually working, and said statement is recorded.

5. However, learned P.O. requested that about three months time may be granted for preparation of service book and for aforesaid payment of dues and benefits to the applicants.

6. In view of the contents of letter dated 31.12.2015 document 'X', and in view of the statement made by learned P.O. on instructions of Dr. Kempi Patil D.C. Civil Surgeon, Thane recorded herein above, present O.A. is disposed off with directions to the Respondent No.1 to complete the service books and pay to the applicants annual increments etc. within period of three months from the date of this order. No order as to costs.
