Learned Presenting Officer places on record order dated 4.6.2016 whereby the disciplinary proceedings initiated by the memo therein referred to came to be dropped. That really speaking works out the Original Application itself.

Mr Bandiwadekar, however, submits that a direction should be given to the Respondents that if the Applicant makes a representation, for releasing of pensionary benefits, an appropriate decision should be taken within a specified time limit.

This Original Application is, therefore, disposed of noting inter alia that the D.E proposed against the Applicant post retirement is dropped. In the even the Applicant makes representation as hereinabove mentioned within two weeks from today, the Respondents shall take a decision thereabout within two months and communicate the outcome to the Applicant within one week thereafter.
