1. Heard Shri P. Suryawanshi, the learned Advocate for the Applicant holding for Shri G.M. Savagave, the learned Advocate for the Applicant and Shri K.B. Bhise, the Presenting Officer for the Respondents.
2. Heard at length. Impugned communication dated 30th May 2014, results in rejecting Applicant's proposal for voluntary retirement.
3. The reasons for rejection reads as follows:-
 - (a) सदर विरामांतर्गत "राज्य शासनाच्या वियमकारी नियंत्रणाखालील कोणत्याही अधिकाऱ्यास तो ३५ वर्षे वयाचा होण्यापूर्वी त्याची शारावकीय सेवेमध्ये प्रवेश केला असेल तर तो ५० वर्षे वयाचा झाल्यानंतर समुचित प्राधिकरणाच्या (३ महिन्यांची) लेखी नोटीस देऊन सेवा निवृत्त होऊ शकेल. तदनुसार डॉ. माने यांच्या जन्मदिनांकाबुसार (दि.०२.०६.१९६६) रवेच्छा निवृत्तीची नोटीस दिल्याच्या दिनांकास (दि.२४.०९.२०१३) त्यांचे वय ५० वर्षांपेक्षा कमी आहे."
 - (b) Rule 85 of the Maharashtra Civil Service, (Pension) Rules, 1982 lays down the eligibility. It transpires that a Government servant can apply for voluntary retirement after attaining the age of 50 years.
4. The reason assigned by the State in the impugned rejection is thus within the para meter prescribed by law. The order is not show to be contrary to law or otherwise erroneous.
5. The O.A. has no merit and dismissed.
