<u>JUDGMENT</u>

Heard Shri A.P. Kalmegh, learned counsel for the applicant and Shri V.A. Kulkarni, learned P.O. for the respondents.

2. The applicant was appointed on the post of Health Worker on 24/01/1994. The applicant became eligible for time bound promotion on 26/04/2012 after completion of 12 years of service. The respondents have not granted 1st and 2nd time bound promotion, therefore, the applicant approached to this Tribunal.

3. The reply is filed by the respondents. During the course of submission, the learned P.O. has submitted that the proposal is sent to the Deputy Director of Health Services by the District Malaria Officer, Akola (R/5) and it is pending.

4. As per the Govt. G.R. of 1995 and subsequent G.R., the specific guidelines are given to grant 1^{st} and 2^{nd} time bound promotion. The applicant is serving from the year 1994. As per submission of applicant, he is not granted 1^{st} and 2^{nd} time bound promotion. The respondents authority is bound to consider the claim of the applicant whether he is entitled or not. Hence, the following order –

<u>ORDER</u>

(i) The O.A. is allowed.

(ii) The respondents are directed to pay 1st and 2nd time bound promotion to the applicant as per the Govt. guidelines from time to time, if he is eligible for the same within a period of three months.

(iii) No order as to costs.
