COMMON ORAL ORDER :

1. A.M.Hajare, learned Heard Shri Counsel for applicants in all these cases, S/Shri N.U.Yadav, V.R.Bhumkar, M.P.Gude, D.R.Patil, B.S.Deokar, I.S.Thorat Smt. M.S.Patni, Presenting Officers for the and respondents in respective cases.

2. Since applicants in all these O.As. have prayed for identical relief of grant of annual increment which was due on 1st July of the respective year of their superannuation, I have heard all these O.As. together and deem it appropriate to decide the same by common reasons.

3. Learned Counsel for the applicants at the beginning of his arguments submitted the information as about the date of retirement of the applicants in the present applications in tabular format. Same is taken on record. Tabular format showing date of retirement of each applicant is as follows:

4. Learned Counsel submitted that since all these applicants retired on attaining the age of superannuation on 30th June of their respective year of retirement, they were entitled for the increment which was due on 1st July of the said year of their retirement. Learned Counsel has relied upon the judgment of the Hon'ble Bombay High Court, Bench at Aurangabad passed on 12.10.2022 in the case of Shri Ramesh Eknath Suryawanshi and Others Vs. the State of Maharashtra through its Chief Secretary and Others, WP No. 10272/2022, which read thus :-

> "3. The issue raised is no longer res integra, having been concluded by the learned Division Bench of the Madras High Court, vide judgment dated 15.09.2017, in WP No.15732/2017, filed by P.Ayyamperumal Vs. The Registrar, Central Administrative Tribunal and others, which judgment has been sustained by the Hon'ble Supreme Court, vide order dated 23.07.2018, in Special Leave Petition (Civil) Diary No.22283/2018. Even this Court has passed

several orders granting such benefits, which have been sustained by the Hon'ble Supreme Court.

4. In view of the above, this petition is partly allowed. The petitioners are entitled to the notional addition of the last yearly increment for the purpose of calculating their pension, gratuity, earned leave, commutation benefits etc. In so far as arrears of the benefits are concerned, the petitioners would be entitled for the same for a period of three years, preceding the date of filing of this petition or as per actuals, whichever is less. Such arrears should be calculated and be paid to the petitioners, on or before 30.12.2022."

5. Respondents have not filed their affidavit in reply. The learned Presenting Officers fairly conceded that the judgments relied upon by the learned Counsel for the applicants are supporting the contentions raised and prayers made by the applicants in their respective O.As. The learned P.Os., however, submitted that the appropriate orders may be passed subject to verification of the date of retirement of the concerned employee and whether the concerned employee retired on attaining the age of superannuation or whether there was any enquiry pending against any of them.

6. Learned P.O. further submitted that in one matter i.e. Petition(s) for Special Leave to Appeal (C) No(s).4722/2021 the Hon'ble Apex Court has granted stay by order dated 05-04-2021 and the said matter is still pending before the Hon'ble Apex Court. Learned P.Os. in the circumstances prayed for passing appropriate orders.

7. As is pleaded in the O.As. all the applicants have retired on 30th June of their respective year of retirement. In view of the judgment of the Division Bench of the Hon'ble Bombay High Court these applicants are therefore entitled for the increment which was due on 1st July, of respective year of their retirement. Based on the said judgment, this Tribunal has decided several number of matters. Learned Counsel has tendered copy of one of such order passed in O.A.No.167/2020 with 168/2020, decided on 22-11-2022. In the aforesaid circumstances, I see no difficulty in allowing these O.As. Hence, the following order:

(i) The O.As. are allowed.

(ii) Subject to verification by the respondents of the particulars as are mentioned in paragraph 5 of the order and subject to the decision by the Hon'ble Apex Court in SLP No.4722/2021, the applicants are held entitled for increment due on 1st of July of their respective year of

retirement. It shall be reckoned with for the purpose of pension and gratuity and other retiral benefits subject to rider that the applicants would be entitled to arrears of monetary benefits for the period of three years only preceding the date of filing Original Applications.

(iii) The respondents are directed to make payment of arrears accordingly within three months from today and also to ensure that revised pension is paid accordingly.

(iv) No order as to costs.
