State of Maharashtra and 2 ors.)</u> came to be confirmed in the Writ Petition. Therefore, the Respondents will have to pass an order exactly of the same nature that they did in that particular matter. An appropriate order in that behalf may be made if need be by issuing the Corrigendum to the order dated 28<sup>th</sup> July, 2016.
