

**JUDGMENT**

1. The Applicant whose father died in harness and who has applied for a job on compassionate ground hereby disputes the effective date from which his application is entered in the relevant waiting list and in that connection,



he seeks the quashing and setting aside of the letters dated 14.08.2014 and 10.11.2014 in the original waiting list. He seeks the relief of his name being incorporated w.e.f.17.05.2013 and he also seeks immediate appointment because according to him, his name was illegally held up which delayed his appointment.

2. I have perused the record and proceedings and heard Mr. C.T. Chandratre, the learned Advocate for the Applicant and Mrs. A.B. Kololgi, the learned Presenting Officer (PO) for the Respondents.

3. The father of the Applicant died on 12.01.2013 as Assistant Sub Inspector. On 13.05.2013, the Applicant applied for appointment on compassionate ground. On 14<sup>th</sup> August, 2014, his application vide Exh. 'A-1' (Page 8 of the Paper Book (PB)) came to be rejected because he did not submit the Domicile Certificate. However, on 10<sup>th</sup> November, 2014, another communication was sent to the Applicant asking him to submit the Certificates of his stay in the state of Maharashtra. He was also asked to submit the mark-list of all his School examinations and the Employment Exchange Registration Card. It is clearly established on record that, ultimately, these Certificates were submitted late in 2015 and w.e.f.10<sup>th</sup> November, 2016, the name of the Applicant was entered in the waiting



list. As far as Domicile Certificate is concerned, there is no material to show that, in the Application Form, the compassionate appointment such Certificates are required to be submitted. The document pointed out by the learned PO would show that for regular appointments such a Certificate was required.

4. However, in my view, the delay, if any, in this matter has occasioned because the Applicant took his own time in submitting the documents that he was called upon to submit. Mr. Chandratre, the learned Advocate for the Applicant told me that the very nature of those four documents being such as to consume time, he probably could not have helped. In my opinion, that by itself would not absolve from responsibility the Applicant and once it is found that post submission, there is not much delay in processing the matter, there is no merit in the Original Application and the same is accordingly dismissed with no order as to costs.
