JUDGMENT

- 1. Heard Shri S.S. Dere, learned Advocate for the Applicant and Ms. S.P. Manchekar, learned Chief Presenting Officer for the Respondents.
- 2. This matter, in fact, was to be decided finally on 19.03.2021. However, learned Counsel Shri Dere on that day made an oral request that his prayer of supplying portion of CCTC footage of the performance of the Applicant in shot-put event be reconsidered especially on the basis of the judgment of the High Court for the States of Punjab and Haryana at Chandigarh in similar matter. He sought time to produce the said judgment.
- 3. We, therefore, informed learned Advocate that he may produce the judgment any time and thereafter we will pass the order after going through the said judgment.
- 4. The learned Counsel for the Applicant relied on the judgment of the High Court for the States of Punjab and Haryana at Chandigarh in the case of **Sonam Versus State of Haryana and Another in C.W.P.No.5294 of 2019 decided on 31.10.2019.** In the said matter prayer was made for production of result of CCTV footage regarding the completion of race of 1 km within stipulated

time. The Hon'ble Single Bench of Punjab and Haryana High Court has allowed the said prayer.

5. Hence, we also pass the similar order as follows:-

The copy of CCTV footage of the performance of the applicant in shot-put event, as claimed by the Applicant, is to be supplied to him by the Respondents within three days from the date on which he makes the application.

6. With this, the Original Application is disposed off with no order as to costs.
