Heard Ms. S.P. Manchekar, learned Advocate for the Applicant and Shri K.B. Bhise, learned P.O. for the respondents.

The Applicant was appointed as Senior Clerk on 21.3.1983 on the Establishment of Respondent No.1. He attained the age of superannuation on 31.5.2012. Till the date of filing of this OA, he was deprived of gratuity, pension and other retiral benefits and therefore he filed this OA.

The learned P.O. states that the Accountant General has sanctioned pension case of the Applicant. Whatever may be the developments, the law is clear on this point. Under Rule 130 of the Maharashtra Civil Services (Pension) Rules, 1982, Gratuity, Regular Pension can be withheld, if departmental or judicial proceedings are pending against the Government servant. In the present case, although there was no clean chit to the Applicant in the matter of furnishing accounts of distribution of pipes and pumps, fact remains that neither departmental nor judicial proceedings either before retirement or till date have been instituted against the Applicant. In that view of the matter, the question of delaying the payment of gratuity and pension did never arise.

The OA stands disposed of with a direction to the Respondents to ensure the payment of gratuity, pension and all

retiral benefits due to the Applicant within three months from the date of passing of this order. It is made clear that in terms of Rule 129-A and 129-B, the Applicant shall be at liberty to submit representation for grant of interest on delayed payment of gratuity and pension, if, the delay is attributable to administrative lapse.
