2. Grievance of the applicants, whose details are given below, is that they have been unjustifiably and arbitrarily deprived of benefits of G.Rs. dt.1/11/1977 & 28/11/1979 ( Annex.- A-4 collectively) as well as G.Rs.

dt.08/06/1995, 20/07/2001 & 1/04/2010, which deal with Time Bound Promotion Scheme and Assured Career Progressive Scheme.

2. Factual background is this. The State Govt. had issued a G.R. dt.01/11/1977 through General Administrative Department directing all departments of the State to amend the rules both for continuation and

confirmation and also for promotion to higher posts, providing for exemption to employees from passing departmental examination on attaining 45 years of age. The Govt. of Maharashtra had issued a G.R. dt.28/11/1979 as well as a Circular for this purpose providing for granting exemption from passing departmental qualifying examination for getting promotion and Time Bound Promotion.

- 3. Though the respondents have initially resisted contention of the applicants, during the course of final hearing, it was conceded that the claim of the applicants is founded on a legal position which is now well settled.
- 4. The applicants have relied on the judgment dtd.21/11/2017 of the Hon'ble Bombay High Court in W.P. No.3643/2009, wherein it is held:
  - " It has been argued on behalf of petitioner, even in the Police department, save Wireless section, the General Administration Department's directions and instructions have been applied and quite a few persons have been given promotions who have attained age of 45 years without requiring them to pass departmental examination for promotion. This particular aspect has not been met with by any counter argument on behalf of the respondent. Further, benefit of promotions appears to have

been given to quite a few departments of the Government including Engineering department, as referred to above without there being suitable amendments to promotional rules. Thus, it appears that so far as Wireless section of Police department is concerned, the authorities are taking a rather hper-technical view under the plea that as the rules have not yet undergone amendment pursuant to the instructions issued thus far. The Tribunal's order in the present case, particularly looking at that another technical post has been given benefit of Government's refusal to extend the same to petitioner who was working in Wireless Section of Police Department of the State is unjustifiable.

In the circumstances, we consider it expedient to follow suit in the decision given by Division Bench in Writ Petition no.6212 of 2011 and other companion matters. Having regard to observations therein, that decision of General Administrative Department of Government would be binding on all departments of the State and a department of Government would not be permitted to take a different stand as it appears only 'Wireless Section' of Police Department has not been extended the benefit."

5. The applicants have further relied on the common judgment of the Hon'ble Bombay High Court dt. 25/01/2022, whereby a batch of W.Ps. was

disposed of. In this judgment, aforequoted observations made in the judgment dt.23/11/1979, were considered, and it was observed:-

"Perusal of the aforesaid observations clearly indicates that even in the Police Department, the directions issued by the General Administrative Department in the matter of grant of time bound promotion had been followed except the Wireless Section. The Court therefore held that the decision of the General Administrative Department would be binding on all departments and it would not be permissible for the Police Department to take a different stand with regard to the Wireless Section. It is not in dispute that this judgment of the High Court has attained finality. The State has not challenged the same before the Hon'ble Supreme Court. It is further informed that the petitioner therein has been granted necessary benefit of time bound promotion.

Similar is the case with regard to the adjudication of Original Application No.422/2016 and connected applications. The Tribunal followed the decision of this Court in Mukund Shankarlal Daima(supra) and granted relief to the applicants therein. The State Government has accepted this decision and has thereafter on 17.06.2020 granted necessary benefit of time bound promotion to the applicants therein. In other words, the employees of the Wireless Section of the Police Department who had approached the Tribunal or this Court have been extended benefit of time bound promotion by not requiring them to pass the requisite examination. The learned counsel for the respondents are justified in relying upon the decision in Arvind Kumar Srivastava(supra). Paragraph 22.3 thereof reads as under:-

<sup>&</sup>quot; However, this exception may not apply in those

cases where the judgment pronounced by the Court was judgment in rem with intention to give benefit to all similarly situated persons, whether they approached the court or not. With such a pronouncement the obligation is cast upon the authorities to itself extend the benefit thereof to all similarly situated persons. Such a situation can occur when the subject-matter of the decision touches upon the policy matters, like scheme of regularisation and the like (see K.C. Sharma v. Union of India). On the other hand, if the judgment of the court was in personam holding that benefit of the said judgment shall accrue to the parties before the court and such an intention is stated expressly in the judgment or it can be impliedly found out from the tenor and language of the judgment, those who want to get the benefit of the said judgment extended to them shall have to satisfy that their petition does not suffer from either laches and delays or acquiescence".

The aforesaid observations clearly apply to the present facts inasmuch as the earlier adjudication in Mukund Shankarlal Daima (supra) was one in rem and not in personam. It was thus the duty of the State to extend the benefit of time bound promotion to all members of the Wireless Section of the Police Department without insisting for specific orders in that regard from the Court. The aforesaid observations also take care of the submission that the claims made before the Tribunal were barred by limitation. It has been rightly observed by the Tribunal that as a model employer the State ought to have extended such benefit to all members of the Wireless Section of the Police Department. Having failed to do so, the State cannot be permitted to raise a grievance regarding bar of limitation in these cases. Admittedly, the State has granted benefit to the employees who approached the Court and there is no reason to exclude the petitioners who are similarly situated. We therefore find that the aspect of limitation would not result in denying the

respondents the benefit of time bound promotion."

6. This Bench while deciding three batches of O.As. by common

judgments dt.19/07/2021, 19/03/21 & 24/12/2020 has relied upon the

judgment dt.21/11/2017 in W.P. No.3643/2009.

7. For the reasons discussed hereinabove, the respondents are

directed to verify cases of the applicants and extend to them benefit of

Time Bound Promotion/Assured Progressive Scheme from the date of

completion of 45 years of age. All consequential benefits flowing from this

determination shall be paid within 3 months from today.

The O.A. is allowed in the aforesaid terms with no order as to

costs.
