### **JUDGMENT**

Heard Shri D.R. Rupnarayan, learned counsel for the applicant and Shri M.I. Khan, learned P.O. for the respondents.

- 2. The applicant retired on 30/6/2019. The respondents have not granted increment which falls on 1/7/2019, therefore, he approached to this Tribunal for direction to the respondents grant one increment which falls on 1/7/2019.
- 3. The O.A. is opposed by the respondents on the ground that the applicant is already retired in the month of June,2019, therefore he cannot claim the increment of July,2019.
- 4. Heard learned counsel for the applicant Shri D.R. Rupnarayan. He has pointed out the Judgment of this Tribunal in O.A.134/2018, decided on 25/01/2019 and the Judgment of Hon'ble Bombay High Court, Bench at Nagpur in Writ Petition No.3457/2021 delivered on 5/5/2022. It is held in the cited decisions, that a government employee who retired on 30<sup>th</sup> June of the year, he/she is entitled for annual increment which falls on 1<sup>st</sup> July of that year. The applicant was retired on 30/06/2019, therefore, he was entitled to get annual increment which falls on 1/7/2019. Hence, the following order –

# <u>ORDER</u>

- (i) The O.A. is allowed.
- (ii) The respondents are directed to grant annual increment to the applicant which falls on 1/7/2019.

O.A. No. 501 of 2021

(iii) The applicant is already retired, therefore, the respondents are directed to revise the pension of the applicant by taking into

consideration one annual increment of July,2019.

(iv) No order as to costs.
