JUDGMENT

1. The 43 applicants in O.A 557/2021 and 41 applicants in O.A 676/2021, seek relief that the Respondents be directed to assign deemed date of promotion in the cadre of Police Sub Inspector. The applicants in O.A 676/2021, who are working as P.S.I have passed the Limited Departmental Competitive Examination 2006, and their names were recommended vide order dated 10.11.2009. The applicants in O.A 557/2021, who are working as P.S.I have passed the Limited Departmental Competitive Examination 2008, and their names were recommended vide order dated 9.3.2011. However, they were not appointed on the basis of merit at the relevant time, but all these applicants were appointed subsequently as the promotions were given to the post of P.S.I, pursuant to the reservation in promotion policy adopted by the Respondent-State. The said policy of reservation in promotion was made applicable subject to the pending Writ Petition No. 8452/2004 before the Hon'ble High Court. Thus, all the applicants were placed below the candidates belonging to the reserved category who were given the promotion.

- 2. Learned counsel for the applicants has submitted that he limits his final relief to the extent that the applicants be granted deemed date of promotion to the post of P.S.I when their other batchmates of L.D.C.E 2006 & 2008 respectively were promoted in the reserved category. He based his prayer solely on the ratio laid down by the Hon'ble High Court dated 4.8.2017, in the case of STATE OF MAHARASHTRA & ORS VIJAY GHOGRE & ORS, W.P 2797/2015.
- 3. Learned counsel submits that the process of promotion from the post of Police Sub Inspector to the post of Police Inspector has commenced and the Respondent-State is likely to issue the orders of promotion to fill up the post of Police Inspector any time soon. Therefore, the present Original Applications have been filed. Initially, we have stayed the process of promotion to the post of P.S.I, by order dated 9th June, 2022. However, the Respondent-State approached the Tribunal and requested to vacate the interim relief granted by this Tribunal by order dated 9th June, 2022, as the post of Police Inspectors are very important and there are many vacancies.
- 4. Both the Original Applications are filed by the applicants on the basis of the decision of the Hon'ble High Court dated 4.8.2017, in the case of STATE OF MAHARASHTRA & ORS VIJAY GHOGRE & ORS, W.P 2797/2015, which is as follows:-
 - "(i) The impugned judgment and order dated 28 November 2014 of Maharashtra Administrative Tribunal to the extent it strikes down the Reservation Act is set aside and the issue of constitutional validity of the Reservation Act is kept open for determination in appropriate case and on an appropriate occasion.
 - (ii) The Government Resolution dated 25th May 2004 is struck down to the extent it makes provisions for reservation

in matters of promotions in favour of Scheduled Caste, Scheduled Tribes, De-Notified Tribes (A), Nomadic Tribes (B), Nomadic Tribes (C), Nomadic Tribes (D) and Special Backward Classes being ultra virus Article 16 (4A) of the Constitution and contrary to the law laid down in M. Nagraj case."

The said order was challenged by the State of Maharashtra before the Hon'ble Supreme Court in State of Maharashtra & Ors Vs. Vijay Ghogre & Ors, S.L.P No. 28306/2017. However, no stay was granted by the Hon'ble Supreme Court. Similar challenges were given in other States and some of those Petitions are also pending before the Hon'ble Supreme Court. The Hon'ble Supreme Court lastly in the matter of JARNIL SINGH & ORS Vs LACHHMI NARAIN GUPTA & ORS, in C.A 629/2022 arising out SLP (C) 30621/2011, by order dated 28.1.2022, while upholding the ratio laid down in M. NAGRAJ's case (2006) 8 SCC 212, held the basic requirement for providing reservation in promotions. The Hon'ble Supreme Court also held that for the purpose of collection of quantifiable data for representation of Scheduled Caste and Scheduled Tribes for the purpose of providing reservation in promotion, cadre, which is part of a "group" is the unit and the data has to be collected with respect to each cadre and it also upheld the conclusion in B.K PAVITRA-2, dated 10th May, 2019 in M.A 1151/2018 in Civil Appeal no 2368/2011, wherein approving the collection of data on the basis of "group" and not cadre is contrary to the law laid by the Hon'ble Supreme Court in the case of M. NAGRAJ (supra) & JARNAIL SINGH (supra). Thus, the challenge given by the Respondent-State in VIJAY GHOGRE's case still pending before the Hon'ble Supreme Court.

5. The promotions were given in the cadre of P.S.I, subject to the outcome of the decision in VIJAY GHOGRE's case pending before the Hon'ble Supreme Court. However, during the pendency

of the said case, the candidates from the reserved category were promoted and resultantly the meritorious candidates from the open category were pushed down. Though they were given the promotions to the post of P.S.I, subsequently their seniority suffered. It has adversely affected subsequent future promotions of the applicants to the present post of P.I. As the applicants were appointed later, they are not coming within the zone of consideration for promotion to the post of Police Inspector.

6. The applicants had challenged the order dated 8.8.2022 of modification of the interim order of this Tribunal dated 9.6.2022 by filing Writ Petition No. 9803/2022 before the Hon'ble Bombay High Court. The Hon'ble Bombay High Court by order dated 18th August, 2022 in the said Writ Petition, has set aside the order of modification of the stay granted by this Tribunal and maintained the earlier order of stay to the post of Police Inspector with directions that the Tribunal to decide matter at the earliest. Further the Hon'ble High Court directed as under:-

"We request to the MAT to dispose of the OA finally at the earlier and to do so without being in any way influenced by the impugned order, especially its observations in paragraphs 8 to 13. As regards paragraph 13, we restore until final disposal of the OA the previous interim/ad-interim order of 9th June, 2022."

It also held as follows:-

"We do not see how the MAT could have speculated as to a likely outcome in the Supreme Court and effectively bypassed the otherwise binding decision of this Court in Vijay Ghogre."

7. In view of this order and the specific directions given by the Hon'ble High Court, we heard these Petitions finally.

- 8. Learned C.P.O while opposing this prayer has submitted that the Respondent-State is bound by the order passed by the Hon'ble Bombay High Court in the case of VIJAY GHOGRE. It is true that stay is not granted by the Hon'ble Supreme Court. The Respondent-State, therefore, has issued the G.R dated 7.5.2021 that the policy of reservation in promotion will not be adopted. However, the decision of the Hon'ble Supreme Court in this matter is awaited for want of quantifiable data. She has submitted that to complete the quantifiable data is a requirement in view of the judgment of the Hon'ble Supreme court in case of JARNAIL SINGH & ORS (supra). Therefore, the Respondent-State is collecting the quantifiable data and it will be completed soon. Thus, the persons who are promoted earlier by giving the benefits of reservation, their position will not be disturbed by demoting them, in view of second clause of G.R dated 7.5.2021. Affidavit is filed to that extent.
- 9. Though, we understand the administrative difficulty of the Respondent-State in correcting their own reservation policy which was adopted under section 5 of the Reservation Act of 2004, we are bound by the judgment of the Hon'ble Bombay High Court in VIJAY GHOGRE's case and especially in view of specific directions given by the Hon'ble High Court by order dated 18.8.2022.
- 10. We, hereby, reproduce for the sake of convenience of the Respondent-State the operative portion in the case of VIJAY GHOGRE's case:-
 - "3. It is clarified that since GR dated 25th May 2004 is struck down, consequential direction is issued to the State Government to take necessary <u>correction</u> steps/measures in respect of promotion <u>already granted</u> within 12 weeks from today which direction is necessitated in view of the order

dated 28th March 2008 of the Supreme Court modifying the interim order of this Court dated 9th March 2007, by which the promotions were made subject to the final decision in the old Writ Petition No. 8452 of 2004."

- 11. As on today, these two orders are not complied with and the orders are not stayed by the Hon'ble Supreme Court. Therefore, the Respondent-State is bound to obey the law laid down by the Hon'ble Bombay High Court and so also implement the same in toto.
- 12. In view of the above we pass the following order:-
- (a) The Respondents are directed to grant deemed date of promotion to the applicants in the cadre of P.S.I of the candidates selected in the Limited Departmental Competitive Examination, 2006, pursuant to the recommendation dated 10.11.2009 and Limited Departmental Competitive Examination, 2008, pursuant to the recommendation dated 9.3.2011, Junior promoted and accordingly grant consequential service benefits such as pay, arrears of pay, seniority and further promotion if any.
- (b) The said order to be complied by 30th November, 2022.
- (c) OAs are allowed.
