

This OA can be disposed of for a short point here and now. The departmental appeal against an order of punishment has remained pending from 5.10.2010. The case of the Respondents was that the record had got destroyed in fire that broke out in Mantralaya. The record was in the manner of speaking reconstructed by the Applicant himself on 22.2.2012 and submitted to the concerned authority. The difficulty in the way of the Applicant is that, consideration of his name for IPS nomination has to be made by 31st October, 2017. This discussion must have shown that the Applicant is not to be blamed at all for anything and by now in fact, the appeal ought to have been decided. This OA is disposed of with a direction that the said appeal be decided within three weeks from today and the outcome thereof be communicated to the Applicant within three working days thereafter.
