#### **JUDGMENT**

- 1. Heard Shri Y.P. Deshmukh, learned Advocate assisted by Shri V.P. Potbhare, learned Advocate for the Applicants and Ms. N.G. Gohad, learned Presenting Officer for the Respondents.
- 2. The Applicants had filed earlier O.A.No.781 of 2013. The Applicants had succeeded in this O.A. and this Tribunal had issued following directions:-

"58. ....... we direct that the Applicants shall be entitled to regular salary from 1<sup>st</sup> August, 2015 and would not be entitled to claim any monetary benefits for the past services rendered by them in spite of their regularization. Needless to state that since the above referred Applicants' services are regularized, they shall be entitled to the continuity in service for all other purposes except monetary purposes from the date of their first appointment. The Government may take an appropriate decision about the scheme of pension applicable to the Applicants."

Accordingly, the Government issued Government Resolution on 23.03.2016 (Exhibit-B. page 18). The relevant portion of the G.R. is as under:-

Applicants have moved the present O.A. for implementation of the same with following prayer:-

### "10. Reliefs sought:

- a) To hold and declare that the Applicants are entitled for being considered for grant of CAS benefits along with arrears of pay and allowances from the respective dates it became due."
- 3. Pending the Original Application Respondents issued Government Resolution on 08.03.2018 (Exhibit R-1, page 139). The relevant portion of the same reads as under:-

..... तथापि त्यांना पूर्वीच्या सेवा कालावधीत केलेल्या सेवेच्या संदर्भात कोणत्याही प्रकारचे आर्थिक लाभ (Monetary benefits) अनुज्ञेय राहणार नाहीत.

### 4. Submissions by the Applicants:

The date of regularization of services of the Applicants should be as per G.R. dated 01.08.2015 and should not be of the date of issue of G.R. dated 23.03.2016.

#### 5. <u>Submissions by the Respondents:</u>

Respondents No.1 and 2 have filed their affidavit-in-reply (page 136) and relevant portion of the reply is at paragraph No.4. The same is as under:-

- "4. It is further submitted that as per the prayer of the applicants the respondent no.1 i.e. State Government as issued G.R. No.Nyay-Pra-2017(246/17)Mashi-1, Dated 08/03/2018 whereby the applicants have granted benefits of Senior Scale, Selection Grade under CAS. The said benefits have been granted to the applicants taking into the consideration the G.R. dated 12/08/2009 and as per the 6<sup>th</sup> Pay Commission's Regulation and also subject to the final decision of Bombay High Court in Writ Petition No.8708/2015. Further it is submitted that the monitory benefits of the placement in Senior Scale, Selection Grade under CAS are entitled to the applicants from the date of issuance of G.R. i.e. 08/03/2018. A copy of the said G.R. dated 08/03/2018 is hereby annexed and marked as **Exhibit R-1**.
- 6. The issue for consideration is whether the Applicant is entitled for CAS from 01.08.2015 as per the judgment given by the Tribunal. As clarified by judgment in O.A.No.781 of 2013 which directed Respondents that the

Applicant shall be entitled to regular salary from 01.08.2015. The same has

been accordingly reflected in the G.R. issued on 23.03.2016 as mentioned

above. The G.R. categorically mentions that the Applicants are entitled for

regularization and monetary benefits from 01.08.2015. Affidavit by

Respondents does not provide any reasons for not doing so.

7. In view of the foregoing, as stated in G.R. issued on 23.03.2016 needs

implementation in true spirit. The Applicants are eligible for monetary

benefits under CAS from 01.08.2015 as directed in the judgment by this

Tribunal. The subsequent G.R. issued on 08.03.2018 which states that the

benefits should be given from date of issue of G.R. namely 23.03.2016 is

erroneous, hence quashed and set aside.

8. Original Application, therefore, succeeds and Respondents are

directed to do needful as directed above in paragraph 7 within a period of

one month from the date of this order. No order as to costs.
