ORAL ORDER

Heard Shri Vivekanand V. Ingle, learned Advocate for the applicants and Shri M.S. Mahajan, learned Chief Presenting Officer for the respondents.

2. The present Original Application has been filed by the applicants seeking following reliefs : -

“B) The results declared by the MPSC on 08.02.2019 in respect of list of qualified candidates for oral interview may kindly be quashed and set aside.

C) The respondent No. 3 MPSC may kindly be directed to declare the results as per guidelines issued in Government Circular dated 16.03.1999 and 13.08.2014

following the proper procedure in respect of horizontal reservation.”

3. Learned Advocate for the applicant has submitted that the applicants were permitted to appear for the oral interview for the post of Taluka Agriculture Officer, Maharashtra Agriculture Services, Group 'B', as well as, Agriculture Officer, Maharashtra Agriculture Services, Group 'B' (Junior) as per the interim relief granted by this Tribunal vide its order dated 26.06.2019. He has submitted that accordingly, the applicants have appeared for the interview. He has further submitted that on the basis of interview conducted by the MPSC the select list has been prepared, but has not been published or acted upon in view of the order passed by this Tribunal on 26.06.2019. He has submitted that the applicants have no objection to permit the MPSC to act upon the select list for selection of the eligible candidates.

4. Learned Chief Presenting Officer has submitted that the interviews of the candidates called for and the present applicants have been conducted by the MPSC and merit list has been prepared, but it has not been published and recommendation regarding selection has not been made by the MPSC in view of the order passed by this Tribunal on 26.06.2019. He has further submitted that meanwhile the Hon'ble High Court of Judicature of Bombay Bench at Aurangabad has passed the judgment in **W.P. No. 4159/2018 WITH W.P. No. 6578/2018 in case of**

CHARUSHILA D/O TUKARAM CHAUDHARI & ORS. Vs. THE STATE OF MAHARASHTRA AND OTHERS on 08TH AUGUST, 2018. He has submitted that the MPSC has prepared select list on the basis of guidelines given by the Hon'ble High Court and, therefore, he prayed to permit the MPSC to proceed further in the recruitment process. He has further submitted that the present OA may be disposed of accordingly.

5. Learned Advocate for the applicant has no objection for dispose of the present OA with the directions to the MPSC to proceed further in the recruitment process as per the directions / guidelines given by the Hon'ble High Court in the above cited decision.

6. In view of the submissions made by both parties, the O.A. is disposed of as the purpose of filing of the O.A. is served with the directions to the respondent No. 3 viz. MPSC to declare the result of the recruitment process taking into consideration the judgment delivered by the Hon'ble High Court in case of **CHARUSHILA D/O TUKARAM CHAUDHARI & ORS. Vs. THE STATE OF MAHARASHTRA AND OTHERS (W.P. NO. 4159/2018)** on 08TH AUGUST, 2018.

There shall be no order as to costs.
