#### <u>ORAL-ORDER</u>

1. Heard Shri S.R. Sapkal, learned counsel appearing for the applicants in all these matters and Smt. Sanjivani K. Deshmukh-Ghate, learned Presenting Officer appearing for respondent authorities.

2. Since in all these matters the issue raised is common and the relief which has been claimed is identical, I have heard all these matters together and deemed it appropriate to decide all these applications by this common order.

3. All these applicants, who are the employees of the Forest Department, were posted in the Tribal/Naxalite Affected Area for certain period. The Government Resolution dated 06.08.2002 provides some additional payment to the Government employees working in the Tribal/Naxalite Affected Area. According to the applicants, since they all were working on the post of Forest Guard while posted in the Tribal/Naxalite Affected Area, they were entitled to get wages of the next higher post i.e. Forester till they worked in the Tribal/Naxalite Affected Area. It is the contention of all these applicants that accordingly the respondents, though had started giving wages in higher pay scale, subsequently vide impugned orders (the impugned orders in all these matters are of different dates and the said information is provided in the tabulare form appended to the present order as Appendix 'A') withdrew the pay scale which was revised and also directed recovery of amount allegedly paid in excess of the entitlement to the applicants.

4. After having served with the aforesaid notices, the applicants approached this Tribunal and this Tribunal by way of an interim relief has stayed the order of recovery. Majority of matters were immediately filed in the year 2019 and few matters came to be filed subsequently. The delay occasioned in filing those applications has been condoned by this Tribunal and other three matters were also tagged with the matters filed in the year 2019 and are today heard together.

After having gone through the pleadings of the 5. parties, it appears to me that had the respondents issued the notices to the applicants before directing the recovery and if the applicants would have been given opportunity of hearing, perhaps the applicants would not be required to approach the The G.R. dated 06.08.2002 is guite explicit. So long Tribunal. works in as the Government employee the notified Tribal/Naxalite Affected Area, he is entitled for wages of the next higher post. If it is the case of the respondents that the pay of some of the applicants was earlier wrongly fixed even then before making any modification or directing recovery, the respondents must have served the concerned applicant with a notice and the opportunity must have been given to the applicant concerned to put forth his submissions.

6. Learned Counsel for the applicants submitted that the applicants are ready to appear before the competent authority and explain how the recovery is wrongly directed against them. The learned Counsel, therefore, prayed for disposing of all these matters with directions to the respondent no.2 and 3 to give personal hearing to all these applicants in regard to the recovery directed against them and for their entitlement of the wages as per the provisions under GR dated 06-08-2002 while working under the tribal/naxalite affected area. Learned PO has consented for passing such order.

7. From the facts which have come on record, it is apparently revealed that, the impugned orders are passed without giving any opportunity of hearing to the applicants or even without any show cause notice to them. In the circumstances, I see no difficulty in accepting the suggestion of the learned Counsel for the applicants to dispose of the present O.A. by giving directions to respondent no.2 and 3 to give personal hearing to all these applicants on the issue of wages paid to them or are being paid to them while working in the tribal/ naxalite affected area and where any recovery is liable against the applicants and to take the appropriate decision thereafter.

8. I re-iterate that learned PO has consented for passing such orders. In view thereof following order is passed:

#### ORDER

- (i) The orders impugned in all these OAs stand set aside.
- (ii) Respondent no.2 and 3 are directed to give personal hearing to all these applicants on the issue of wages paid to them or are being paid to them while working in the tribal/naxalite affected area, and about the

sustainability of the recovery directed against them and to take a fresh decision thereafter.

- (iii) The aforesaid exercise has to be completed within the period of 6 months from the date of this order, till then the respondents shall not cause any recovery on the basis of the earlier orders.
- (iv) With the directions as aforesaid, all these OAs stand disposed of, however, without any order as to costs.
