ORAL ORDER:

1. Heard Shri Sanjay Kolhare, learned Counsel for the applicant and Shri N.U.Yadav, learned Presenting Officer for the respondent authorities.

2.Applicant has filed the present O.A. being aggrieved with rejection of her request by respondent no.2 to provide appointment to her in place of her deceased husband. Learned Counsel for the applicant submitted that though in the application the applicant has requested for compassionate appointment, in fact, since her husband was working on the post of Sweeper, her intention was to claim appointment under the recommendations of Lad-Page Committee. Learned Counsel further submitted that the request of the applicant came to be rejected as if she was claiming appointment on the compassionate ground. Learned Counsel further submitted that, subsequently the respondents have considered the request of the applicant and now her name has been included in the waiting list of the candidates who are eligible to be appointed under the recommendations of the Lad-Page Committee. Learned Counsel tendered across the bar a copy of waiting list

wherein name of the applicant appears at Sr.No.11. Learned Counsel in the aforesaid circumstances, has prayed for disposal of the application with direction to respondent authorities to provide the appointment to the applicant under the recommendations of the Lad-Page Committee as per her seniority in the waiting list.

3. Learned P.O. fairly concedes for passing appropriate order. Hence, I pass the following order:

ORDER

[i] Respondent no.2 shall consider the candidature of the present applicant for appointing her on the post of Sweeper under the recommendations of the Lad-Page Committee as per her place in the seniority list as published by it.

[i] O.A. stands disposed of in the aforesaid terms, however, without any order as to costs.
