### JUDGMENT

# [Delivered on this 16<sup>th</sup> day of December, 2016]

1. All these Original Applications are being disposed of by this common judgment and order, since the issues involved in all these Original Applications are one and the same.

2. The applicants are serving as Shift Manager/ Dairy Manager, Class-III in Government Milk Scheme, Dhule. The applicants were initially appointed as Assistant Dairy Chemist, Class-III and thereafter they were promoted to the post of Shift Manager/Dairy Manager, Class-III. Thereafter they were due for promotion for the post of Dairy Manager, Class-II. The respondent Nos. 2 & 3 published gradation list and deemed date was granted to the applicants. The State level the seniority list was also published in the year 2004. Some of the Shift Managers, Class-III have challenged the said seniority list by filing O.A. Nos. 691/2006 and 420/2007 before the Principal Seat of this Tribunal at Mumbai. In the said OAs the Tribunal issued directions to the respondents to publish seniority list at State level. In the said seniority list various dates of deemed date of promotion were granted to the applicants. However, they were not granted deemed date of promotion to the post of Dairy Manager, Class-II from the date on which they were due for such. The applicants have, therefore, filed the separate Original Applications. The details of the applicants as regards their date of appointment as Assistant Dairy Chemist, promotion as Shift manager, Class-III and the date of promotion on the post of Dairy Manager, Class-II etc., are given in detail in the following chart: -

3. The applicants are claiming that they are liable to get deemed date of promotion as mentioned in the chart aforesaid, even their juniors were promoted. It is stated that the respondents have published the list of 2010 in which juniors to the applicants were shown as promoted as Class-II in the year 1984. The said names of junior employees are as under: -

4. The applicants have, therefore, claimed the following relief :-

"A. The Respondent No. 2 and 3 may kindly be directed to consider the case of the applicant for promotion in the cadre of class-II as the employees who are junior to the applicant are already promoted as class-II.

B. The Respondent No. 2 & 3 may kindly be directed to grant the deem date of promotion

to the applicant in the cadre of class II of 1985 on the date on which his juniors were promoted and to grant other consequential benefits.

C. The Respondent No. 2 and 3 may kindly be directed to take the decision on the representation of the applicant for granting him deem date and promotion in the cadre of class-II in view of his modified deem date in the cadre of class-III."

5. The respondent Nos. 2 to 4 have filed their reply affidavit. The respondents have admitted almost all the facts. It is admitted that the applicants are not promoted to Class-II. It is also admitted fact that some juniors were promoted earlier than the applicants. It is also admitted that the seniority list at State level was finalized in the year 2010 and the juniors to the applicants were already promoted before publication of said seniority list, as per the seniority list of 2007.

6. The applicants have filed rejoinder and given the details as to how the juniors of the applicants are promoted. In O.A. No. 843/2011, it is stated that one Shri S.S.

Abhyankar, who was appointed on 13.3.1969 was promoted on 13.12.1979, Shri Phanse, who was appointed on 10.3.1969 was promoted on 20.9.1980 and Shri Kothawale, who is junior to the applicant was promoted on 17.09.1985.

7. Heard Shri J.B. Choudhary – learned Advocate for the applicants and S/Shri M.P. Gude, I.S. Thorat, D.R. Patil & Smt. Resha S. Deshmukh – learned Presenting Officers for the respondents. We have also perused the application, affidavit, affidavit in reply filed by the respondents, rejoinder affidavit filed by the applicant and various documents placed on record by the learned Advocates for the respective parties.

8. The only material point is to be considered as to whether the applicants are entitled to deemed date of promotion as claimed by them to the post of Dairy Manager, Class-II?

9. As already stated most of the facts have been admitted in these cases. The respondents have also admitted fact that some juniors to the applicants have been promoted prior to the applicant and, therefore, there remains no doubt that the applicants are entitled to deemed date of promotion from the date on which their juniors have been promoted. It is also true that in view of the directions given in O.A. Nos. 691/2006 and 420/2007, the impugned seniority list published earlier was quashed and set aside and the respondents were directed to publish the provisional list and invite objection and suggestion, if any. The said order is dated 17.6.2008 and it seems that as per the said direction the State level seniority list was published and objections were called. The said list became final on 28.10.2010 and in the said seniority list, seniority of the applicants have been changed and they became more senior in the list. Admittedly, some juniors have been promoted earlier to the applicants and, therefore, obviously it was necessary for the respondents to grant deemed date of promotion to the applicants from the date on which their respective juniors have been promoted. We are, therefore, satisfied that the claim of the applicants is genuine and, therefore, we pass the following order: -

O.A.NOs.277,278,634,842, 843 & 846-2012

#### ORDER

(i) The present Original Applications are allowed.

(ii) The respondent Nos. 2 & 3 are directed to consider the cases of the applicants for promotion in the cadre of Class-II since the date on which their juniors are promoted to such post.

(iii) The respondents are directed to pay all the consequential financial benefits in view of such deemed date of promotion to the applicants. Such benefits would be restricted to three years prior to the date of filing the Original Applications

(iv) In the facts and circumstances of the cases, there shall be no order as to costs.
