2. The learned P.O. has filed reply of respondent no.3. It is taken on record and copy is given to the learned counsel for the applicant. The matter is admitted.

3. Looking to the prayer, the O.A. is heard and decided finally with the consent of learned counsel for both the parties.

4. The applicant was appointed on the post of Police Constable on 07/09/2007. Thereafter, he was promoted on the post of Head Constable. The departmental enquiry was initiated and punishment was awarded by the Commissioner of Police, Amravati by which the applicant is terminated from the service. The applicant has filed appeal before respondent no.2, i.e., the Additional Principal Secretary (Home Department). As per the submission of the applicant, it is pending since 26/07/2022. Therefore, prayed for direction to respondent no.2 to decide the appeal.

5. The relief prayed in the present O.A. is very simple. Only direction is sought by the applicant to decide his appeal.

<u>ORDER</u>

(i) The O.A. is allowed.

(ii) The respondent no.2 i.e. Additional Principal Secretary (Appeal) is directed to decide the appeal filed by the applicant as early as possible.
