- 2. Case of the applicant is as follows. By order dated 30.09.2021 (A-1) the applicant was promoted as Police Sub-Inspector, transferred Group-B (Non-Gazetted) and from the office of Superintendent of Police, Nashik (Rural) to the office of Superintendent of Police, Nagpur (Rural). On 23.03.2023 he made a representation (A-2) that on medical grounds of himself, elder brother and son he be transferred to a place of his choice. He gave two choices. By order dated 30.06.2023 (A-3) 104 Police Sub-Inspectors who were not due for transfer, were transferred on request as per choice given by them. Nonconsideration of representation of the applicant for such transfer was in breach of Notification dated 14.07.2021 (A-4) which provides for change in Revenue Division by way of transfer inter alia on the ground of Heart Surgery of the employee's brother who is dependent on him, etc, after serving for one year in the Division. Brother of the applicant who is totally dependent on him had undergone Heart Surgery. This was stated in the representation. By order dated 17.12.2023 (A-5) the applicant was informed that his representation was turned down by P.E.B.-2. No reason was, however, assigned therefor. Hence, this Original Application.
- 3. To resist the O.A. reply of Dy. Superintendent of Police, Head Quarter, Nashik, Rural is placed on record. Stand taken in this reply is

that requests for transfer were considered keeping in view reasons

furnished and vacancies for accommodating the employees as per their

choice. As per Clause 8 of Notification dated 14.07.2021 the applicant

was not due for transfer. He was required to serve for three years in the

Division. It was not possible to accommodate the applicant on either of

the establishments given by him as his choice.

4. The main ground on which communication dated 17.12.2023

is impugned is that it does not spell out any reason for rejection of

representation of the applicant. This communication shows that

representation of the applicant was placed before P.E.B.-2. There is

nothing on record to conclude that while dealing with representation of

the applicant P.E.B.-2 had not considered its merits. No case is, therefore,

made out to interfere with the impugned order. **The O.A. is accordingly**

dismissed with no order as to costs.
