Heard Shri G.G.Bade, learned counsel for the applicant and Shri S.A.Sainis, learned P.O. for the respondents.

- 2. The applicant was appointed as Muster Assistant on 16.11.1983. Order of his termination dated 30.06.1990 was stayed by Labour Court, Amravati in Writ Petition No.207/1990 on 09.08.1990. He was reinstated and absorbed in the respondent department by order dated 20.04.2000 (Annexure A-3) by relying on G.R. dated 22.02.1993 (Annexure A-4). He retired on superannuation on 30.06.2012. As per G.R. dated 21.04.1999 (Annexure A-5) pay of the applicant was protected at the time of his absorption.
- 3. Stand of respondent no.4 is that the applicant can be treated to be a Government Servant only from the date of his absorption i.e. 24.04.2000 and he will be entitled to benefits accruing on that basis only.
- 4. At the time of final hearing the applicant placed on record order of his retirement on superannuation dated 30.06.2012 (at page 69).
