<u>JUDGMENT</u>

Heard Shri S.N. Gaikwad, learned counsel for the applicants and Shri M.I. Khan, learned P.O. for the respondents.

2. The learned counsel for the applicants Shri S.N. Gaikwad has filed documents. Same are taken on record and commonly marked as Exh-X for identification.

- 3. The case of the applicants in short is as under –
- 4. All the applicants were initially appointed on the post of Police Constable. Lateron they were posted on the post of Head Police Constable (Wireless Operator). The appointment of applicants were made by following due procedure of law.
- 5. The respondents have introduced the scheme to promote the employees in Wireless Section and to motivate them to appear in the Classification Examination. The provision has been introduced in the Bombay Police Manual. All the applicants have passed the proficiency test and therefore they are entitled for three advance increments as per the G.R. dated 03/01/1979. The applicants have passed the proficiency test, but they are not granted three advance increments by the respondents. Therefore, they approached to this Tribunal for the following reliefs –
- "(i) allow the instant original application with costs;
- (ii) be pleased to direct the respondent No. 3 to release the three advance increments on passing of Proficiency Test;
- (iii) further be pleased to direct the respondents to pay arrears thereon and also release all consequential service benefit arise out of grating advance increments and also revised the pension considering the said benefits;"
- 6. The reply is filed by respondent nos.2 and 3. The respondents have denied the claim of the applicants and submitted that representations of the applicants are pending.
- 7. During the course of submission, the learned counsel for applicants Shri S.N. Gaikwad has pointed out the Judgment of this Tribunal in O.A.No. 50/2023 with connected matters, decided on 02/08/2023. This

Tribunal has held that in view of the Judgment of Hon'ble Supreme Court in the case of *State of Uttar Pradesh and Others Vs. Arvind Kumar Shrivastav*, 2015 (1) SCC,347, the applicants are entitled for equal treatment as like similarly situated employees to whom benefits of three advance increments were granted.

8. As per the submission of learned counsel for applicant, the Maharashtra Administrative Tribunal, Bench at Aurangabad in O.A.No.647/1996 passed the following order –

"In view of the above discussion, this application is partly allowed. The recovery ordered is quashed and set aside The respondents are directed to consider the restoration of advance increments as per the practice prevailing before 1.1.1986, similar to the practice being followed by the Government of India even now after 1.1.1986. The continuance is being suggested only for Radio Mechanics and Wireless Operators and not for Electricians, since the Government of India is not giving any special pay to the Electricians. However, since the amount already paid to the Electricians was not due to any mistake on their part, the same need not be recovered. There will be no order as to costs."

9. As per the submission of learned counsel for the applicants, the benefits of three advance increments were given by the State Government as per the direction given by the Maharashtra Administrative Tribunal, Bench at Aurangabad in O.A.No.647/1996. Therefore, the applicants are entitled for the same relief, because, they are similarly situated employees and in view of the G.R. and Judgment of Hon'ble Supreme Court in the case of *State of Uttar*

Pradesh and Others Vs. Arvind Kumar Shrivastav (cited supra). Hence, the following order –

<u>ORDER</u>

- (i) The OA is partly allowed.
- (ii) The respondents are directed to decide the representations of the applicants within a period of two months from the date of receipt of this order.
- (ii) No order as to costs.
