Heard Shri I.N.Choudhari, learned counsel for the applicant and Shri S.A.Sainis, learned P.O. for the respondents.

- 2. The applicant joined the respondent department on 30.09.2003 as Forest Guard and retired on superannuation on 30.06.2019. It is his grievance that his retiral benefits were paid belatedly i.e. in June, 2021. According to him, he is entitled to get interest on delayed payment as per Rules.
- 3. Stand of respondents 3 and 4 is as follows-

The applicant stood retired on superannuation on 30-6-2019. It is pertinent to note here that, the

respondents released the pension payment vide order dated 20-5-2021 in the month of June 2021. It is submitted that, as per G.R and after preparation of papers of pension and pensionery benefits of the applicant as per 7th Pay Commission by the office of respondent the same had been sent to the pay verification office at Nagpur for verification. Needless to say that this period was so alarming as Covid-19 pandemic spread through at the Country i.e. during the period of 2019 to 2021, and as such due to pay verification of the applicant by Pay Verification Office took some time for the release of pension payment order and gratuity. The situation was exceptional as the Covid-19 Pandemic was at its peak and this is exceptional circumstance. Due to this there is some delay for which the respondents were not at fault. The delay is bonafide and not deliberate on the part of the respondents.

4. It was submitted by Shri I.N.Choudhary, learned Advocate for the applicant that had the respondents stuck to the schedule prescribed under Rules 120 to 125 of the M.C.S. (Pension), Rules, 1982, retiral benefits would have been paid to the applicant before onset of

Covid-19 pandemic. Considering the date of retirement of the applicant

and the schedule prescribed under Rules 120 to 125 of the M.C.S.

(Pension), Rules, 1982, this submission of the applicant deserves to be

accepted. Therefore, payment of interest on account of belated

payment of gratuity and pension will have to be directed. The O.A. is

allowed. The applicant is held entitled to get interest as per Rules 129-A

and 129-B on account of delayed payment of gratuity and pension. The

respondents are directed to pay the same within two months from

today. No order as to costs.
