<u>IUDGMENT</u>

Heard Shri G.K.Bhusari, learned counsel for the applicant and Shri A.M.Ghogre, learned P.O. for the Respondents.

2. The case of the applicant in short is as under-

The applicant is working as Civil Surgeon, at Yavatmal. The applicant is suspended as per order dated 07.07.2022. Since more than three months no any charge sheet is given against him. Therefore, the applicant approached to this Tribunal for revocation of suspension order dated 07.07.2022.

3. Heard learned counsel for the applicant. He has pointed out the Judgment of this Tribunal in 0.A.No.853/2021 dated 27.01.2022 and the Judgment of Hon'ble High Court in W.P.No.7506/2018 dated 17.07.2019. He has also pointed out the G.R. dated 09.07.2019. Learned P.O. has submitted that as per his instruction till date charge sheet is not served to the applicant. Applicant is under suspension for more than 90 days. As per the judgment of Hon'ble Supreme Court in the case of *Ajay Kumar ChoudharyVs. Union of India Through its Secretary and Another* the suspension cannot be continued for more than 90 days. Government of Maharashtra has also issued G.R. dated 09.07.2019. As per the G.R. suspension cannot be continued more than 90 days. Admittedly applicant is under suspension since 07.07.2022. Hence, the following order.

ORDER

- 1. The O.A. is allowed.
- The suspension order dated 07.07.2022 is hereby revoked.
 Respondents are directed to reinstate the applicant.
- 3. No order as to costs.
