Government servant completes requisite length of service with good

conduct, and becomes payable on the succeeding day. In view of this

legal position the O.As. are allowed in the following terms-

The applicants are held entitled to one notional increment falling

due on the immediately succeeding day of their retirement, and all

consequential benefits flowing therefrom. The respondents are directed

to pay arrears accordingly within three months from today, and further

ensure payment of revised pension. No order as to costs.
