Heard Shri G.G.Bade, learned counsel for the applicant and Shri A.P.Potnis, learned P.O. for the respondents.

2. The applicant was working in the respondent department. He retired on superannuation on 30.06.2022. It is his submission that benefits of increments notionally due on 01.07.2022 ought to have been extended to him. Hence, this O.A..

3. In his reply respondent no.3 has referred to G.R. dated 28.06.2023 issued by the Finance Department of Government of Maharashtra. It states-

मंत्रालयीन प्रशासकीय विभागांनी त्यांच्या अधिनस्त कार्यालयातील
विभागप्रमुखांना कळवावे.

In view of this position the O.A. is allowed. The applicant is held entitled to notional increment falling due on 01.07.2022, and consequential benefits. The same shall be extended to him. No order as to costs.
