Heard Shri B.Kulkarni, learned counsel for the applicant and Shri H.K.Pande, learned P.O. for the respondents.

- 2. The applicant retired on superannuation on 28.02.2021. Amount of his gratuity and regular pension were withheld. He filed O.A.No.597/2022 before this Bench. It was allowed by Judgment dated 28.03.2023 and the respondents were directed to release gratuity and regular pension to the applicant within one month from the date of the Judgment. While passing this Judgment issue of interest was kept open. In this background the applicant has filed instant O.A.. He has pressed only prayer [A] which seeks direction to pay interest on delayed payment of gratuity.
- 3. In their reply respondents 1 and 2 have pleaded that in view of pendency of departmental enquiry gratuity was withheld as per rules. However, by order dated 10.05.2023 A.G., Mumbai sanctioned payment of gratuity. Said order of A.G., Mumbai was received by respondent no.2 on 23.05.2003. Before approaching this Tribunal for grant of interest on delayed payment of gratuity the applicant ought to have filed an application under Rule 129-A(2) of the M.C.S. (Pension) Rules, 1982.

4. In the instant case ends of justice would be met by directing

the respondents to pay interest on delayed payment of gratuity as per

Rule 129-A of the M.C.S.(Pension), Rules. Hence, the order.

<u>ORDER</u>

The O.A. is allowed in the following terms-

The respondents are directed to calculate

extent of delay in paying amount of gratuity, and pay

interest for delayed payment as per Rule 129-A of the

M.C.S. (Pension) Rules, 1982 to the applicant within two

months from today. No order as to costs.
