JUDGMENT

Heard Shri P.V.Thakre, learned counsel for the applicant and Shri S.A.Deo, learned C.P.O. for the respondents.

2. Case of the applicant is as follows. She joined the respondent department as Clerk-Cum-Typist and was posted at Chandrapur on 07.10.2016. Her husband is also serving at Chandrapur in the office of D.F.O.. Their son is aged three years. In January, 2023 she declined promotion to the post of Senior Clerk because it was difficult for her to serve outside Chandrapur. She requested for retention in Chandrapur (Annexures A-1 & A-2). She further requested

that if at all she was to be transferred, she could be accommodated on another post in Chandrapur itself. By the impugned order dated 30.06.2023 (Annexure A-3) she was transferred to Wardha. By application dated 03.07.2023 (Annexure A-4) she again requested for retention in Chandrapur. Her request was not considered. Hence, this O.A..

- 3. Stand of the respondents is as follows. From 10.07.2016 the applicant had worked at Chandrapur. She had completed two tenures of three years each and had thus already availed extension. She was overdue for transfer. She was relieved on 03.07.2023. Refusing promotion cannot create a right of retention. Her application dated 10.02.2023 (Annexure A-2) for retention was considered by Civil Services Board. The Board, for the reasons stated in the Minutes, recommended her transfer to Wardha. For all these reasons the O.A. is liable to be dismissed.
- 4. Following facts are not in dispute. The applicant was due for transfer. She requested for retention. Her application was considered by the Board as reflected in Minutes dated 03.03.2023 (Annexure R-2). The Board recommended as follows.

5. In her rejoinder the applicant has contended that one Varun

Darwade attached to Wardha office is working in the office of

respondent no.3 (at Nagpur) on deputation since last 4 years and this

aspect, too, should be taken into account. There is no merit in this

submission. It was for the concerned establishments to deal with the

deputation in the light of administrative need.

6. To sum up, the applicant was due for transfer. Her

application for retention at Chandrapur was considered by the Board.

The Board recommended her transfer to Wardha by recording reasons

which were cogent. Thus, there is no ground to interfere with the

impugned order. The O.A. is accordingly dismissed with no order as to

costs.
