IUDGMENT

Heard Shri N.D.Thombre, learned counsel for the applicant and Shri A.M.Khadatkar, learned P.O. for the Respondents.

2. Case of the applicant in short is as under:-

The applicant was working on the post of Medical Officer Group-B with the respondents. The applicant is retired on 30.06.2020 after the age of superannuation. After the retirement of the applicant, it is for the respondent particularly respondent no. 4 to pay pension and all pensionary benefits to the applicant within a period of three to six months. The learned counsel for the applicant has submitted that the applicant has received 90% amount of DCRG, but the applicant has not been granted Regular Pension, Commutation of pension, 10% of remaining gratuity, previous leave not sanctioned and payment for the period from 22.06.2007 to 28.01.2009, 2nd time bound promotion, difference of pay and allowances from 7th Pay Commission and other pensionary benefits. The respondents have not filed reply.

- 3. Learned P.O. has strongly objected the O.A..
- 4. During the course of arguments, the learned counsel for the applicant has submitted that the respondents have granted second time O.A.No.706/2021

bound promotion to the applicant, but the respondents have not fixed the

pension by counting second time bound promotion and other pensionary

benefits. Pension and pensionary benefits are the property of the retired

employee. It was the duty of the employer to process the pension case.

5. From the perusal of communication dated 14.01.2021, it

appears that letter was written to the Accountant General, Nagpur by Civil

Surgeon, General Hospital, Wardha and requested to verify the Service

Book. It appears from the above communication that the final pension case

is not submitted to the concerned department. The applicant is getting

provisional pension. Hence, the following order-

ORDER

1) The O.A. is allowed.

2) The respondents are directed to pay the pension and pensionary

benefits to the applicant within a period of three months from

the date of receipt of this order. The applicant is at liberty to

claim interest, if any, as per Rules.

3) No order as to costs.
