2. By the impugned order dated 18.12.2021 (Annexure A-2) earned leave of 44 days (from 15.04.2021 to 28.05.2021) was debited to account of the applicant. The applicant ventilated his grievance against the same by representation dated 30.08.2021 (Annexure A-1) as follows-
