### <u>IUDGMENT</u>

<u>Judgment is reserved on 11<sup>th</sup> Jan., 2024.</u> <u>Judgment is pronounced on 18<sup>th</sup> Jan., 2024.</u>

Heard Shri G.G.Bade, ld. counsel for the applicants and Shri S.A.Sainis, ld. P.O. for the Respondents.

- 2. These two connected O.As. are being decided by this common judgment.
- 3. Case of the applicants is as follows. The applicants were appointed as Forest Guard and they were working in Pench Tiger Project under Wild Life Division. Thus, they were working in area which is notified as Tribal area by G.R. dated 09.03.1990 (A-4). They are entitled to get benefit of one step promotional pay scheme introduced by G.R. dated 06.08.2002 (A-3). By judgment dated 08.03.2023 (A-6) this Bench has held that benefit of G.R. dated 06.08.2002 was to be extended to the applicants in that proceeding (bearing O.A. No. 673/2022) if they were eligible for the same. On principle of parity the benefit be extended to these applicants as well.
- 4. In their reply respondents 2 to 6 have averred as follows. As per G.R. dated 09.03.1990 97 Villages in Ramtek Tahsil, District Nagpur have been included in Tribal Zone. Request applications have been received by this respondents to extend benefit of G.R. dated 06.08.2002 to eligible employees working in Pench Tiger Project. In O.A. No. 673/2022 this Bench has passed an order extending benefit of G.R. dated 06.08.2002 to those of the applicants who are working in Tribal Area, if they are eligible to get the same. Accordingly, said benefit is extended to

23 persons who were applicants in O.A. No. 673/2022. Nine more Original Applications are pending before this Bench wherein the applicants have sought identical relief.

## 5. Respondents 9 to 13 have averred as follows:-

3. It is submitted that, the Tribal Development Department G.R. dtd. 09.03.1990 is published for implementation of Tribal Sub Plan (TSP). The list of villages published in this G.R. merely states about implementation of above said plan. After that, as per the knowledge of answering Respondents, no such list of villages is published so far by concerned Department.

4. It is submitted that, the GAD G.R. dtd. 06.08.2002 was published later having the provision of OSPS, only after above mentioned Tribal Development Department G.R. dtd. 09.03.1990. It is pertinent to note that, after implementation of OSPS, the Home Department published G.R. dtd. 07.12.2004, which lists/demarcates the Naxalite Areas in Districts of Maharashtra State. Thus, on the basis of this the State Government Employees working in Naxalite Areas were granted one step promotional pay (OSPS), as per sub rule 3(7) of G.A.D. G.R. dtd. 06.08.2002. But till date no such list of

villages / areas of Tribal Region is published either by Tribal Department or by G.A.D. which specifically mentions that, the State Government Employees working in these areas will be eligible for granting one step promotional pay (OSPS) as per sub rule 3(7) of G.A.D. G.R. dtd. 06.08.2002.

Due to this ambiguity the Joint Director, Accounts and Treasuries, Nagpur has sent a letter dtd. 03.08.2023 to its Directorate Office, Mumbai seeking guidance on this issue. Also Joint Director of Accounts and Treasuries, Nagpur has further sent the letter in relation to above narrated matter on 10.10.2023. The letter copies together are annexed herewith as ANNEXURE R-1. Thus from above narration it is clear that unless and until guidance is received and the ambiguity is resolved from Directorate Office, Mumbai, the answering Respondents would not be able to comply with Point No.2 of above mentioned judgement.

6. In judgment dated 08.03.2023 in O.A. No. 673/2022 (A-6) this Bench held:-

The G.R. dated 06/08/2002 is very clear. The material portion of the G.R. dated 06/08/2002 is reproduced as below:-

"आदिवासी क्षेत्रातील बिकट परिस्थितीत शासनाच्या योजनांची प्रभावीपणे अंमलबजावणी करणाऱ्या शासकीय अधिकारी/कर्मचारी यांना त्या भागात काम करताना येणाऱ्या विविध अडचणींचा विचार करून तसेच नक्षलग्रस्त/संवेदनशील भागात (जिविताची) सुरक्षितता इत्यादी बाबी लक्षात घेवून त्यांना काही प्रोत्साहनपर सवलतीही देण्यात आलेल्या आहेत. आदिवासी भागाच्या विकासासाठी राबविण्यात येत असलेल्या शासनाच्या विविध योजनांचा पुरेपूर लाभ तेथील जनतेला मिळावा, त्यांचा विकास व्हावा यासाठी तळमळीने काम करणाऱ्या अधिकारी / कर्मचाऱ्यांच्या अडीअडचणी दूर व्हाव्यात आणि त्यांना जोमाने काम करण्यास प्रोत्साहन मिळावे याकरीता विविध सवलती देण्यात आलेल्या आहेत त्यात सुधारणा करणे तसेच काही अतिरिक्त सवलती देण्याची बाब शासनाच्या विचाराधीन होती.

- (७) सर्व पदांसाठी एकस्तर पदोन्नती : आदिवासी व नक्षलग्रस्त क्षेत्रात काम करण्यासाठी प्रोत्साहन म्हणून गट 'अ' ते गट 'ड' मधील सर्व पदधारकांना संबंधित कर्मचारी/अधिकारी त्या क्षेत्रात कार्यरत असेपर्यन्तच्या काळात त्यांनी धारण केलेल्या मूळ पदाच्या नजीकची विरष्ठ पदोन्नतीची वेतनश्रेणी व त्या अनुषंगाने वेतननिश्चितीचा लाभ देण्यात यावा. ज्या कर्मचारी/अधिकाऱ्यांना सेवांतर्गत आश्वासित प्रगती योजनेचा लाभ देण्यात आलेला आहे त्यांना आणखी विरष्ठ पदाच्या वेतनश्रेणीचा लाभ अनुज्ञेय नसेल. ही एकस्तर पदोन्नतीची योजना दि.१ जुलै, २००२ पासून अंमलात येईल आणि ती संबंधित कर्मचारी/अधिकारी आदिवासी/नक्षलग्रस्त क्षेत्रात कार्यरत असेपर्यन्तच अनुज्ञेय राहील. त्या क्षेत्रातून कर्मचारी/अधिकारी बिगर आदिवासी क्षेत्रात परत आल्यावर तो त्यांच्या मूळच्या संवर्गातील वेतनश्रेणीत पूर्वीच्या वेतनाच्या अनुषंगाने वेतन घेईल."
- 5. From the plain reading of the G.R., it appears that the G.R. dated 06/08/2002 is applicable to the Scheduled Tribal area and also for naxalite area. The areas are defined in the G.R. of 2004 in respect of naxalite area, the G.R. dated 09/03/1990 shows that villages Gara, Sawara and Pipriya of Nagpur District, are enlisted in the tribal area. As per contents of the G.R. dated 06/08/2002, the employees who are working in the tribal / naxalite areas, are entitled to get promotional pay. The G.R. of 2004 is only in respect of naxalite area. This G.R. does not show that the tribal areas are excluded from the benefit of G.R. dated 06/08/2002. The G.R. dated 06/08/2002 clearly shows that the employees who are working in tribal area or naxalite area, are entitled to get promotional pay. The applicants are working in the tribal area, therefore, they are entitled to get benefit of G.R. dated 06/08/2002. Hence, the following order –

#### <u>ORDER</u>

- (i) The O.A. is allowed.
- (ii) The respondents are directed to verify the list of villages of tribal area in Nagpur District and pay promotional pay as per the G.R. dated 06/08/2002, if they are eligible for the same.
- (iii) This order is applicable only to the applicants.
- (iv) No order as to costs.

उपरोक्त संदर्भाकिंत विषयान्वये सविनय सादर करण्यात येते की, संदर्भ १ अन्वये सामान्य प्रशासन विभागाने सदरच्या शासन निर्णयात मुद्दा क्र. ३ (७) मध्ये आदिवासी व नक्षलग्रस्त क्षेत्रात काम करण्यासाठी प्रोत्साहान म्हणून गट 'अ' ते 'ड' मधील सर्व पदधाराकांना संबंधीत कर्मचारी/अधिकारी त्या क्षेत्रात कार्यरत असेपर्यन्तच्या काळात त्यांनी धारण देण्यात यावा, ज्या कर्मचारी /अधिक-यांना सेवांतर्गत आस्वासित प्रगती योजनेचा लाभ अनुज्ञेय नसेल. ही एकस्तर पदोन्नतीची घोषणा दिनांक १/०७/२००२ पासून अंमलात येईल आणि ती संबंधीत कर्मचारी/अधिकारी आदिवासी / नक्षलग्रस्त क्षेत्रात कार्यरत असेपर्यंतच अनुज्ञेय राहील. त्या क्षेत्रात्न कर्मचारी/अधिकारी बिगर आदिवासी क्षेत्रात परत आल्यावर ता त्याच्या मुळच्या संवर्गातील पूर्वीच्या वेतनाच्या अनुषंगाने वेतन घेईल अशी तरतुद आहे.

संदर्भ क्र. १ ला अनुसरुन गृह विभागाने दिनांक ०७/१२/२००४ रोजी राज्यात जिल्हातील तालुके/गाव नक्षलग्रस्त घोषीत केलेले आहे. उपरोक्त संदर्भ १ व २ मधील तरतुदींचा एकत्रित विचार करता नागपूर विभागातील गडचिरोली, गोंदिया, चंद्रपूर, भंडारा जिल्हातील तालुके/गाव नक्षलग्रस्त घोषीत केले असल्याने

सद्यास्थितीत या क्षेत्रात कार्यरत अधिकारी व कर्मचान्यानां प्रोत्साहन म्हणून एकस्तर पदोन्नतीची योजना १ जुलै २००२ पासुन अनुजेय केली आहे. सद्यास्थितीत उपरोक्त नमुद प्रमाणे नागपूर विभागात फक्त नक्षलग्रस्त क्षेत्रातच संदर्भ २ नुसार या क्षेत्रात कार्यरत अधिकारी कर्मचारी यांना एकस्तर पदोन्नती योजना लागु असुन संदर्भ क. ३ ते ६ मध्ये न्यायालयीन प्रकरणी नमुद याचिकार्कत्यांनी नागपूर जिल्हातील विशेषतः रामटेक तालुक्यात आदिवासी भाग असल्याने उपरोक्त नमुद संदर्भ १ मधील मुद्दा ३ (७) मध्ये आदिवासी क्षेत्रात कार्यरत अधिकारी व कर्मचारी यांना प्रोत्साहन म्हणून एकस्तर पदोन्नती योजना लागू करण्यासंबंधीचे तरतुद असल्याचे नमूद करुन मा. न्यायाधिकरणास या क्षेत्रात कार्यरत अधिकारी/कर्मचारी यांना एकस्तर पदोन्नती योजना लागू करण्याविषयी दाद मागितली आहे. याविषयी संदर्भ क्र. ३ मधील न्यायालयीन प्रकरणात मा. न्यायाधिकरणाने अंतीम निकालात खालील प्रमाणे बाबी नमुद केलेले आहे.

परंतु संदर्भ क्र. ७ मधील शासन निर्णयात आदिवासी विकास विभागाने महाराष्ट्रातील त्यावेळेच्या १३ जिल्हातील ४८ तालुक्यातील एकुण ६५२० गावांचा समावेश आदिवासी उपयोजना क्षेत्रामध्ये करण्यात आल्याचे नमुद आहे. सदरच्या शासन निर्णयात नागपूर जिल्हातील रामटेक तालुक्यात आदिवासी उपयोजना क्षेत्रामध्ये एकुण ९७ गावांचा समावेश आहे. (पृ. क्र. ५७ व ५८) या व्यतिरिक्त संदर्भ १ मधील शासन निर्णय निर्गमित झाल्यापासुन आजपर्यंत शासन स्तरावरुन (सामान्य प्रशासन विभाग किंवा आदिवासी विकास विभाग) नागपूर जिल्हयात

आदिवासी तालुका/गाव यांची यादी संदर्भ क्र.१ मधील मुद्दा क्र. ३(७) मध्ये नमुद तरत्दीस अन्सरुन प्रसिद्ध करण्यात आली नाही.

सबब उपरोक्त नमुद प्रमाणे संदर्भ क्र. ७ मधील नागपूर जिल्हातील रामटेक तालुक्यात आदिवासी उपयोजना क्षेत्रामध्ये एकूण ९७ गावांचा समावेश असलेल्या गावांनाच आदिवासी भाग गृहीत धरुन या क्षेत्रात कार्यरत अधिकारी व कर्मचारी यांना प्रोत्साहन म्हणून एकस्तर पदोन्नती योजना लागू करावी किंवा कसे? की शासन स्तरावरुन नागपूर जिल्हयात आदिवासी बहुल तालुका/गांवाची यादी प्रसिध्द झाल्यानंतरच सदरच्या क्षेत्रात कार्यरत अधिकारी व कर्मचारी यांना प्रोत्साहन म्हणून एकस्तर पदोन्नती योजना लागु करावी यासंबंधी स्पष्टतः नसल्याने संभ्रमाची स्थिती निर्माण झालेली आहे.

याशिवाय मा. न्यायाधिकरणाने त्याच्या निकालात मुद्दा क्र. ३ मध्ये सदरचा निकाल हा फक्त याचिकर्त्यांनाच लागु राहील असे नमुद केले असल्याने याच विषयाला अनुसरुन नागपूर जिल्हातील रामटेक तालुक्यात कार्यरत अधिकारी व कर्मचारी मा. न्यायाधिकरणाकडे दाद मागत आहेत. त्यामुळे या कार्यालयाच्या स्तरावर न्यायालयीन प्रकरणाची संख्या दिवसेंनदिवस वाढत चाललेली आहे.

In judgment dated 08.03.2023 this Bench has concluded that benefit of G.R. dated 06.08.2002 is to be extended to employees working in Tribal Area as well and G.R. of 2004 which speaks only about extending benefit of G.R. dated 06.08.2002 to employees working in Naxal Area, does not exclude from its purview Tribal Area for extending such benefit. By G.R. dated 09.03.1990 Tribal Areas of various Districts including Nagpur have been notified. These being the facts, order identical to the one passed on 08.03.2023 in O.A. No. 673/2022 will have

to be passed by applying principles of parity and judicial discipline.

Hence, the order:-
