#### **COMMON JUDGMENT**

Heard D.R.I. Patil, learned counsel for the applicants, Shri A.M. Ghogre, learned P.O. for respondent nos.1 to 4 and 7 and Shri D.M. Kakani, learned counsel for respondent nos.5 and 7 (in O.A.No.321/2022).

- 2. Heard D.R.I. Patil, learned counsel for the applicants and Shri A.M. Ghogre, learned P.O. for respondents (in O.A.No.322/2022).
- 3. Both the Original Applications are filed by the applicants for direction to the respondents to grant time bound promotion as per the G.R. after completion of 12 years from the date on which they are absorbed on the post of Sectional Engineer.
- 4. Heard Shri A.M. Ghogre, learned P.O. for respondent nos.1 to 4 and 7 and Shri D.M. Kakani, learned counsel for respondent nos.5 and 7 (in O.A.No.321/2022). Heard D.R.I. Patil, learned counsel for the applicants and Shri A.M. Ghogre, learned P.O. for respondents (in O.A.No.322/2022). The O.A. are opposed by the respective respondents.
- 5. Heard D.R.I. Patil, learned counsel for the applicants. He has pointed the Judgment of Hon'ble Bombay High Court, Bench at Aurangabad in Civil Writ Petition No.8009/2021 and other connected Writ Petitions, decided on 02/08/2022 and Judgment in Writ Petition No.2330/2021 and other connected Writ Petitions, decided on 19/09/2022 and Judgment in Writ Petition No.1936/2023, decided on 20/02/2023. He has also pointed out the Judgment of

Hon'ble Bombay High Court, Bench at Nagpur in Writ Petition No.884/2022, decided on 22/08/2022.

- 6. The learned Counsel for the applicants has pointed out Judgment of Hon'ble Bombay High Court, Bench at Aurangabad Writ Petition No.2330/2021 in the case of *Upendra S/o Madhavrao Kulkarni Vs. State of Maharashtra and others* and other connected Writ Petitions, decided on 19/09/2022. The Hon'ble Bombay High Court, Bench at Aurangabad has observed in para 10 as under
  - "(10) Consequently, Writ Petitions are allowed by directing respondents not to take into consideration the upgradation granted on the post of Sectional Engineer while considering the entitlement of the petitioners for grant of financial upgradation under the ACPS. In case the petitioners are found eligible for grant of such financial upgradation, the consequential benefits be extended to them within a period of four months from today. The Writ Petitions are allowed to the above extent."
- 7. Relying on the earlier decisions the Hon'ble Bombay High Court,
  Bench at Aurangabad in WP 1936/2023 has observed in para nos.2,3&4 as under
  - 2. Since the matters in which identical fact situation was brought before the Court, have been decided by the judgment dated 19/09/2022, delivered by a Co-ordinate Bench of this Court in Writ Petition No.2330/2021 (Upendra Madhavrao Kulkarni Vs. State of Maharashtra and others) and a group of petitions, we requested the learned Advocate Shri. A.G. Vasmatkar, appearing for the Company, to assist the Court, since he had appeared in all these matters, which were decided vide the said judgment.

- 3. After granting a pass over, the learned Advocate Shri Vasmatkar, submits on instructions that, this Writ Petition can be disposed off in the light of the judgment dated 19/09/2022, and the Company would resort to the exercise of verification, as is directed by this Court in paragraph No. 10. of the said judgment.
- 4. In view of the above, **the Writ Petition is disposed off**, for the reasons set out in the judgment dated 19/09/2022. The cases of each of these petitioners would be verified and those petitioners, who are found to be eligible for grant of such financial up-gradation, the consequential benefits would be extended to them within a period of four months from today. To make it clear, the exercise of verifying each case of these petitioners and the grant of consequential benefits, if held eligible, would be completed, on or before 31/05/2023.
- 8. The learned Counsel for the applicants has pointed recent the Judgment of Hon'ble Supreme Court in Civil Appeal No.1985/2022 in the case of *the State of Maharashtra and Another Vs. Madhukar Antu Patil and Another*, decided on 21/03/2022. Hon. SC in the case of State of Mah. Vs. Patil in CA 1985/22 decided on 21/03/2022. The Hon'ble Apex Court in para-6 has held as under
  - "6. In view of the above and for the reasons stated above, the present appeal succeeds in part. The impugned judgment and order passed by the High Court as well as that of the Tribunal quashing and setting aside orders dated 6.10.2015 and 21.11.2015 down-grading the pay scale and pension of the contesting respondent are hereby quashed and set aside. It is observed and held that the contesting respondent shall be entitled to the first TBP on completion of twelve years from the year 1989, i.e., from the date on which he was absorbed on the post of Civil Engineering Assistant and his pay scale and pension are to be revised accordingly.

However, it is observed and directed that on re-fixation of his pay scale and pension, as observed hereinabove, there shall not be any recovery of the amount already paid to the contesting respondent, while granting the first TBP considering his initial appointment from the year 1982."

9. From the Judgment of Hon'ble Supreme Court cited above, it is clear that the applicants are entitled to get 1<sup>st</sup> time bound promotion after completion of 12 years from the date on which they are absorbed on the post of Sectional Engineer. Hence, the following order –

#### **ORDER**

## In O.A. 321/2022 -

- (i) The O.A. is allowed.
- (ii) The respondents are directed to pay time bound promotion to the applicants as per the G.Rs. dated 08/06/1995 and 20/07/2001 after completion of 12 years of service from the date of absorption on the post of Sectional Engineer. If the benefits are already given to the applicants, then that should be continued.
- (iii) No order as to costs.

# In O.A.322/2022 -

- (i) The O.A. is allowed.
- (ii) The respondents are directed to pay the benefit of the G.Rs. dated 08/06/1995 and 20/07/2001 for grant of time bound promotion to the applicants after completion of 12 years from the date of absorption on the post of Sectional

Engineer. If the benefits are not given to the applicants, the said benefits be given within a period of four months from the date of receipt of copy of this order.

(iii) No order as to costs.
